Chief Hudak: The item before you is receiving of a grant. I just wanted to explain exactly what it does, Monica Cardoza who is our records manager. our system which is becoming obsolete, including the recording of systems. The time sensitive part of this is actually putting it into the current building that we are in and also transitioning it into the new building, along with the backup...I'll put it to IT for any other timeline issues...

IT Director Rodulfo: Thank you. So, the current system is going to be applied in April of next year. With this grant we are going to be able to acquire this technology. I think proving in the industry is that its stable. It implements enhance 911 technologies, compatible with voice for IT; and we are also getting the backup, Absolution, and also the voice recorder. AT&T has implemented this is the City of Miami, Miami Beach, Aventura, and Hialeah successfully, so we have good background information on this technology.
