Commissioner Lago: Very nice. When you say advertising, you are advertising for contractors or who are you advertising for?

Assistant Public Works Director Keller: Yes, for construction.

Commissioner Lago: OK. Alright. Perfect.

Mayor Valdes-Fauli: Thank you.

Commissioner Lago: Budget's in place, next 90 days – OK.

Commissioner Mena: Have the residents been informed about the latest update?

Assistant Public Works Director Keller: We will notify them of any construction that will take place as we do on any of our projects.

Commissioner Lago: The reason why and it's a good point that Commissioner Mena brought that up, because I was under the impression that we are starting the first week in April. So, I know that obviously that's not a possibility now. When will we be rolling out the RFP?

Assistant Public Works Director Keller: Its going through the RTQ process, so its an existing, we have existing vendors who are approved, and they will be bidding on the project.

Commissioner Mena: So that goes more quickly.

Assistant Public Works Director Keller: Yes.

Commissioner Lago: Like a wheel, like a wheel, they are already qualified.

Assistant Public Works Director Keller: Correct.

Commissioner Lago: Let me ask you a question in regard to that. I don't expect you to know the answer. In reference to this wheel, how often does these entities need to be recertified? Here comes ACM Santamaria with a response.

Assistant City Manager Santamaria: Yes. Well typically it's not a wheel.

Commissioner Lago: I know.

Commissioner Lago: Maybe five years.

Commissioner Lago: I ask that question as a follow-up to my insurance question.

City Manager Iglesias: I think its three years Commissioner. We'll follow-up with a potential renewal.

Commissioner Lago: Alright.

City Manager Iglesias: We can follow-up on that and get back with you.

Commissioner Lago: Let's send the residents of Monegro a little notification, just something simple. Maybe a flyer, we have the NSA, just flyer the area.

Commissioner Mena: Or put together an e-mail for us and we can forward it to...

Commissioner Lago:...these guys over there, just send it to them. The constant communication is important, I mean, they've been through a lot, so they want to make sure we are still moving in the right direction.

Assistant City Manager Santamaria: We'll be happy to provide a status update in writing by email. We'll send it to you, and you can distribute it to the community.
