RESOLUTION NO. 2019-98

A RESOLUTION OF THE CITY COMMISSION, ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES GENERAL BIENNIAL ELECTION, WHICH WAS HELD ON APRIL 9, 2019, WHEREIN VOTERS RE-ELECTED RAUL J. VALDES-FAULI, TO HOLD THE OFFICE AS MAYOR, GROUP I, FOR A TERM OF TWO YEARS; SAID TERM TO BEGIN AT NOON ON APRIL 26, 2019, UNTIL NOON ON APRIL 23, 2021.

WHEREAS, on April 9, 2019, following the closure of the polls at 7 p.m., in connection with the City of Coral Gables General Biennial Election, the Miami-Dade Elections Department counted the votes cast for those candidates who sought to hold the office for Mayor (Group I); and

WHEREAS, the tabulation of vote count of the total ballots cast yielded the following results:

Jeannett Slesnick	4,198	49.28%
Raul J. Valdes-Fauli	4,321	50.72%;

WHEREAS, acceptance of said results along with Miami-Dade County's Certification of Election Tabulation document, and the City of Coral Gables Clerk's Certificate and Declaration of Result, have been brought forth for the City Commission's consideration, review and approval;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing "**WHEREAS**" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby accept the City Clerk's Certification and Declaration of the Result from the Coral Gables General Biennial Election (2019), and made a part of this Resolution, in connection with the re-election of Raul J. Valdes-Fauli, to hold the office as Mayor, Group I, for a two-year term to begin at noon on April 26, 2019, until noon on April 23, 2021.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.

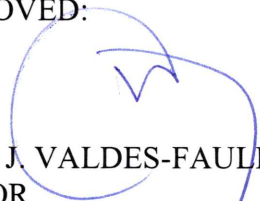
