RESOLUTION NO. 2019-100

A RESOLUTION ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES GENERAL BIENNIAL ELECTION, WHICH WAS HELD ON APRIL 9, 2019, WHICH RESULTED IN A RUN-OFF ELECTION ON APRIL 23, 2019 WHEREIN VOTERS ELECTED RALPH CABRERA AND JORGE FORS, JR., TO PARTICIPATE IN SUCH RUN-OFF ELECTION SCHEDULED FOR APRIL 23, 2019.

WHEREAS, on April 9, 2019, following the closure of the polls at 7 p.m., in connection with the City of Coral Gables General Biennial Election, the Miami-Dade Elections Department counted the votes cast for those candidates who sought to hold office for City Commissioner (Group IV); and

WHEREAS, the tabulation of vote count of the total ballots cast yielded the following results:

Ralph Cabrera	3,320	39.75
Jorge Fors, Jr.	2,567	30.73
Jackson Rip Holmes	270	3.23
Carmen Olazabal	2,196	26.29

WHEREAS, acceptance of said results along with Miami-Dade County's Certification of Election Tabulation document, and the City of Coral Gables Clerk's Certificate and Declaration of Result, have been brought forth for the City Commission's consideration, review and approval;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby accept the City Clerk's Certification and Declaration of the Result from the Coral Gables General Biennial Election (2019), and made a part of this Resolution, in connection with the election of Ralph Cabrera and Jorge Fors, Jr., to participate in a run-off election on April 23, 2019.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
