## **RESOLUTION NO. 2019-101**

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE CITY CLERK'S CERTIFICATION AND DECLARATION OF THE RESULT OF THE CITY OF CORAL GABLES GENERAL BIENNIAL RUN-OFF ELECTION, WHICH WAS HELD ON APRIL 23, 2019, WHEREIN VOTERS ELECTED JORGE FORS, JR., TO HOLD OFFICE AS CITY COMMISSIONER, GROUP IV, FOR A TERM OF FOUR YEARS; SAID TERM TO BEGIN AT NOON ON APRIL 26, 2019, UNTIL NOON ON APRIL 23, 2023.

WHEREAS, on April 9, 2019, following the closure at 7 p.m., in connection with the City of Coral Gables Run-Off Election, the Miami-Dade Elections Department counted the votes cast for those candidates who sought to hold office for City Commissioner (Group IV); and

**WHEREAS**, as a result of the above tabulation, a run-off election took place on April 23, 2019, between Ralph Cabrera and Jorge Fors, Jr., resulting in the following:

Ralph Cabrera	2,918	48.56%
Jorge Fors, Jr.	3,091	51.44%

WHEREAS, acceptance of said results along with Miami-Dade County's Certification of Election Tabulation document, and the City of Coral Gables Clerk's Certificate and Declaration of Result, have been brought forth for the City Commission's consideration, review and approval;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES, FLORIDA:

- **SECTION 1.** That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.
- **SECTION 2.** The City Commission does hereby accept the City Clerk's Certification and Declaration of the Result from the Coral Gables General Biennial Election (2019), in connection with the election of Jorge Fors, Jr., to hold the office of City Commissioner, Group IV, said term to begin at noon on April 26, 2019, until noon on April 23, 2023.
- **SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
