A RESOLUTION OF THE CITY COMMISSION APPROVING THE CONCEPT FOR A WORK OF PUBLIC ART TITLED "MEAN AVERAGE" BY TONY CRAGG IN CONJUNCTION WITH THE PLAZA CORAL GABLES DEVELOPMENT PROJECT AT 2901 PONCE DE LEON BOULEVARD IN FULFILLMENT OF THE ART IN PUBLIC PLACES REQUIREMENT FOR PUBLIC ART IN PRIVATE DEVELOPMENT. (UNANIMOUSLY RECOMMENDED BY THE ARTS ADVISORY PANEL APPROVAL/DENIAL VOTE: 4 TO 0, AND THE CULTURAL DEVELOPMENT BOARD APPROVAL/DENIAL VOTE: 6 TO 0).

WHEREAS, Agave Plaza Trustee (hereafter referred to as the Developer) is constructing a mixed-use project at 2901 Ponce de Leon Boulevard, The Plaza (the "Project"). The Developer has chosen the option of petitioning for a waiver of the Art in Public Places Fee requirement by acquiring and installing artwork within the project as specified in the Zoning Code, Article 3, Division 21; and

WHEREAS, the Project meets the requirement to contribute one percent (1.0%) of the aggregate project value to the Art Acquisition Fund pursuant to Article 3, Section 3-2103 Subsection A2 of the Coral Gables Zoning Code; and

WHEREAS, Tony Cragg (the "Artist"), selected by the Developer, was approved as a qualified artist by the Arts Advisory Panel in accordance with the City of Coral Gables Art in Public Places: Funding, Goals, and Implementation Guidelines; and

WHEREAS, on July 17, 2019, a concept proposal of the public artwork titled "Mean Average" was presented to the Arts Advisory Panel for review, which recommended acceptance of the concept to the Cultural Development Board; and

WHEREAS, on September 17, 2019, the concept proposal of the recommended public artwork titled "Mean Average" was presented to the Cultural Development Board, which reviewed it and accepted the recommendation of the Arts Advisory Panel to recommend the Artists' concept; and

WHEREAS, the proposed art piece is estimated to be \$1,238,149 (one million, two hundred thirty-eight, one hundred forty-nine dollars) which is less than the required 1% of the Aggregate Project Value of \$4,100,000 (four million, one hundred thousand dollars) (as shown on Exhibit A attached hereto); therefore, the Developer will propose additional works of art, restoration of a historic building, or pay any balance to the Art Acquisition Fund;

# NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** That the foregoing "Whereas" clauses are here hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

**SECTION 2.** The City Commission does hereby approve the Artist's concept and proposed preliminary budget for a work of public art titled "Mean Average" in partial fulfillment of the Art in Public Places requirement, attached hereto as **Exhibit A**, provided that such work shall meet all other applicable criteria of the Zoning Code, and other applicable codes, statutes, laws, rules, and regulations; provided that the Developer receive approval for installation of additional works of art, restoration of a historic building, or pays any difference in the balance to the City for deposit into the Art in Public Places fund.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.











# A SITE PLAN SHOWING THE LOCATION OF THE ARTWORK


























# A STATEMENT OF HOW THE PROPOSED ARTWORK ADDRESSES BROADER CITY URBAN DESIGN GOALS

THE SCULPTURE WILL BE THE FIRST INTRODUCTION TO THE WELL THOUGHT OUT DESIGN OF THE PLAZA CORAL GABLES AND FURTHER DEFINE THE AREA AS A PLACE OF RELAXATION, BEAUTY, AND A SENSE OF CONTEMPLATION.

#### **Proposed Treatment**

Note: The sculpture has not been examined by RLA and the following treatment steps are based on previous experience with similar sculptures. It is assumed that the sculpture is in good condition and that only maintenance is required.

- Document with before, during, and after high-resolution digital photographs and a detailed treatment report.
- 2. Remove any minor corrosion products and mineral deposits mechanically.
- Clean all surfaces to remove dirt and grime. Use filtered tap water to rinse, followed by cleaning with a conservation-grade detergent. Rinse using distilled water.
- 4. Apply two coats of a sacrificial proprietary cold paste wax to the surface, followed by buffing.





#### b. AIPP WAIVER REQUEST - THE PLAZA

Bill Brady introduced himself as the gallery representative working with the developers on the selection of artists and artwork for The Plaza and provided his professional background. It was noted that proposed artists were presented and pre-qualified at the previous Arts Advisory Panel meeting. Mr. Brady stated that three projects are being requested at this time for approval in compliance with the Art in Public Places program.

Mr. Brady explained the process of artist selection and stated that fifty artists were considered and eventually narrowed to a select few.

#### i. TONY CRAGG

Mr. Brady presented the first proposal, a large-format sculpture by artist Tony Cragg. Mr. Cragg, he said, is from Liverpool with commissions around the world including an exhibition along Park Avenue in 2013. The piece being considered for this installation, he said, is from the Park Avenue exhibition and is titled "Mean Average." Mr. Brady provided further background about the artist's interest in materials and science. The developers, he continued, viewed Cragg's sculptures in Dallas and selected this piece. The placement of the artwork is being proposed on the corner of Ponce de Leon in the front of The Plaza and will include a bench surrounding the piece.

Dr. Deupi asked if the piece is being anchored at grade or on a concrete foundation. Mr. Brady responded that it would be installed on concrete and possibly on a (raised) plinth. He stated the dimensions as approximately nineteen feet high by eight feet in diameter.

Ms. Tschumy asked where the work was cast. Mr. Brady stated that it was cast in Germany at a cost close to \$400,000, it could cost \$15,000 to ship from Europe and another \$17,000 to install on site. Ms. MacDonald-Korth advised the importance of including a maintenance plan. With no further questions the following motion was made:

Mr. Brito made a motion recommending approval of the waiver request to incorporate artwork as presented by artist Tony Cragg into The Plaza development project facing Ponce Circle Park. Ms. MacDonald-Korth seconded the motion, which was unanimously approved.

## a. PRIVATE DEVELOPER WAIVER REQUEST - THE PLAZA

Ms. Cathers introduced Mr. Brady and Ms. Rosenthal and stated their appearance before the Board to request placement of artwork as part of The Plaza development project in partial fulfillment of the Art in Public Places requirement.

Mr. Brady addressed the board, saying he is representing The Plaza with a proposal of an artwork by artist Tony Cragg. The Board was presented with materials regarding the artist and the proposed artwork titled "Mean Average." Tony Cragg, Mr. Brady said, is a British artist who has lived most his life in Germany; the artwork proposed reflects the artist's early exploration of stacking items that has since evolved and is a profile of a human face spun around in many directions. "Mean Average", Mr. Brady continued, is a cast bronze sculpture standing 19 (nineteen) feet high with a 9 (nine) feet diameter base. The proposed location, he said, is across from Ponce Circle Park (where Ponce de Leon Blvd., Palermo Avenue, and Coconut Drive meet). Mr. Brady added that the artwork has exhibited several times internationally, including exhibition at the Yorkshire Sculpture Park in the UK and Park Avenue in New York. The piece, he said, is coming from the Marion Goodman Gallery.

The Board discussed traffic flow and sight lines around the piece, and how the piece will be anchored and maintained. It was noted that the sculpture will be set back from the street and may include seating nearby. Mr. Brady stated that Museovault will be contracted to do the installation with Rosa Lowinger and Associates entering into a contract to maintain the artwork. Ms. Cathers said ownership of the artwork will be with the property owner and they will be responsible for the ongoing maintenance.

Staff informed the Board that the Arts Advisory Panel reviewed the proposal and made a motion recommending the Cultural Development Board to recommend approval of the artwork and waiver request in partial fulfillment of the Art in Public Places requirement. The Board was advised that the Cultural Development Board's recommendation will move forward to the City Commission.

Ms. Morris asked if additional artworks will be presented. Mr. Brady said he's aware of two additional artworks currently in development, including a proposed fountain designed by artist Jean-Michel Othoniel. With no further discussion, the following motion was made:

Ms. Horwitz made a motion recommending approval of the Art in Public Places waiver request by The Plaza development project to incorporate artwork by artist Tony Cragg into The Plaza plans as presented and as recommended by the Arts Advisory Panel. Ms. Morris seconded the motion, which was unanimously approved.

Mr. Brady and Ms. Rosenthal thanked the Board and left the meeting.
