#### **ITEM TITLE:**

**Ordinance on Second Reading. Zoning Code Text Amendment.** An Ordinance of the City Commission of Coral Gables, Florida providing for text amendments to the City of Coral Gables Official Zoning Code, Article 2, "Decision Making and Administrative Bodies," Division 3, "Board of Architects," Section 2-302, "Membership; Terms; Vacancies; Removal" removing the term limitations for members for the members of the Board of Architects; providing for severability, repealer, codification, and an effective date.

### PLANNING AND ZONING BOARD RECOMMENDATION:

The Planning and Zoning Board at their October 16, 2019 meeting recommended approval of the Zoning Code Text Amendment with modifications (vote: 5 yes -1 no). All modifications have been incorporated into proposed text amendment.

#### **BRIEF HISTORY:**

As requested by the City Manager, Staff has prepared a Zoning Code text amendment to remove the eight consecutive year term limitation for Board of Architects members. Members of the Board of Architects are appointed by the City Manager, subject to the approval of the Commission.

At the October 16, 2019, Planning & Zoning Board meeting, the Board recommended modifications to the proposed text amendments (vote 5-1) to include Section 2-302.C.

All modifications have been incorporated into the proposed text amendments and are provided in Exhibit A. The Staff Report and recommendations with attachments is provided as Exhibit B. The Planning & Zoning Board excerpts meeting minutes are provided as Exhibit C.


