I found no evidence of an enclosed garage permit being issued. There was an awning permit issued in 2003 that reflects the enclosure, however.

I also found a contract and inspection report from "Snapp Industries". In this document they reference "recent new addition".

Being that this happen right after Hurricane Andrew, I do not know the policy at that time with the inspection process.

I explained to her at that time, that acceptance of the permit for awnings doesn't mean this was legal at that time.

There was a listing of enclosed garages way back when I was in Code Enforcement. I do not know if that exists now. There was also an amnesty period where they could have applied for the permit without being penalized. Maybe the previous owner applied, but never followed through?

Anyway, I hope this helps.
