## **RESOLUTION NO. 2019-367**

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING A CHANGE ORDER TO THE CLEAN AND SAFE AMBASSADOR PROGRAM CONTRACT RFP-4580-18-JE WITH MYDATT SERVICES, INC. D/B/A BLOCK BY BLOCK, PURSUANT TO SECTION 2-764(B), APPROVAL OF CHANGE ORDERS AND CONTRACT MODIFICATIONS, IN THE ESTIMATED AMOUNT OF \$1,800,000 TO INCREASE THE ORIGINAL AWARD AMOUNT TO ACCOMMODATE WORK REQUIRED THROUGH THE POTENTIAL SIX(6) YEAR TERM OF THE CONTRACT.

WHEREAS, the City Commission has demonstrated an ongoing commitment to maintaining streetscape of the Miracle Mile and Giralda Plaza; and

WHEREAS, the maintenance and custodial services will be supplemental to the baseline level of service provided by the City; and

WHEREAS, the Downtown District coverage area for this service is on Miracle Mile from LeJeune Road east to Douglas Road and on Giralda Plaza; and

WHEREAS, the City entered into an agreement with Mydatt Services, Inc., d/b/a Block By Block, to provide Ambassador Services on Miracle Mile and 100 Block of Giralda Plaza beginning in December of 2017, and

WHEREAS, Block By Block currently provides supplemental maintenance and cleaning services for Miracle Mile and Giralda Plaza pursuant to contract RFP-4580-18-JE; and

WHEREAS, the City wishes to continue the supplemental maintenance and cleaning services being provided by Block By Block;

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1.** The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

**SECTION 2.** That the City Commission pursuant to Sec. 2-764(B) of the Procurement Code, authorizes an increase in the award amount for contract number RFP-4580-18-JE in an estimated additional amount of \$1,800,000 over the potential six (6) years of the agreement; with the estimated annual appropriation from the Parking fund of \$450,000.

**SECTION 3.** That this Resolution shall become effective upon the date of its passage and adoption herein.
