SUBJECT: Award Recommendation RFP 2019-043 Workers Compensation and Third-Party Liability Claims Administrative

Services

At the February 25, 2020 City Commission Meeting an award recommendation for RFP 2019-043 Workers Compensation and Third-Party Liability Claims Administrative Services will be included on the agenda. This memorandum serves to notify you that in accordance with Section 2-763 of the City Code entitled "Contract Award", my recommendation to the City Commission for award of the subject RFP is as follows:

- Accept the recommendation of the Procurement Officer to award the RFP and authorize negotiations with John's Eastern Company, Inc. the highest ranked responsive and responsible proposer, for Workers Compensation and Third-Party Liability Claims Administrative Services, RFP 2019-043.
- 2) Should negotiations fail with the top-ranked proposer, negotiations shall commence with the next highest ranked responsive-responsible proposer, up to the second ranked qualified Proposer, until a satisfactory agreement and contract amount that is fair, competitive, and reasonable is reached.

On October 22, 2019, the Procurement Division of Finance formally advertised, issued, and distributed Workers Compensation and Third-Party Liability Claims Administrative Services, Request for Proposals (RFP) 2019-043. Thirty-four (34) prospective proposers downloaded the RFP package from Public Purchase, the City's web-based e-Procurement service.

On December 2, 2019, four (4) firms submitted proposals in response to the RFP: Broadspire; CorVel Enterprise Comp, Inc.; Johns Eastern Company, Inc.; and PMA Management Corp.

On January 16, 2020, the Evaluation Committee convened to evaluate the four (4) responsive proposals and ranked the firms in the following order of preference: Johns Eastern Company, Inc. (top-ranked); CorVel Enterprise Comp, Inc. (second ranked); PMA Management Corp. (third ranked); and Broadspire (fourth ranked). The Evaluation Committee determined that Johns Eastern Company, Inc. was the highest ranked responsive-responsible proposer. The Evaluation Committee further recommended that should negotiations fail with Johns Eastern Company, Inc., that negotiations commence with the next ranked firm, up to the second ranked firm, until an agreement and contract amount acceptable to the City has been reached.

After successful negotiations, a Professional Services Agreement will be executed. A more detailed description of the RFP, proposal response and evaluation results will be provided to you as part of the Agenda package.
