Required Communications

- GASB Statement No. 89, Accounting for Interest Costs Incurred Before the End of a Construction Period

This representation letter is provided in connection with your audit of the basic financial statements of the City of Coral Gables, Florida (the City) as of and for the year ended September 30, 2019, for the purpose of expressing an opinion on whether the financial statements are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

We confirm, to the best of our knowledge and belief, that as of the date of this letter:

Financial Statements

- 1. We have fulfilled our responsibilities, as set out in the terms of the professional services agreement dated July 29, 2019 and arrangement letter dated August 7, 2019, for the preparation and fair presentation of the financial statements referred to above in accordance with U.S. GAAP.
- 2. We acknowledge our responsibility for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.
- 3. We acknowledge our responsibility for the design, implementation and maintenance of internal control to prevent and detect fraud.
- 4. Significant assumptions used by us in making accounting estimates, including those measured at fair value, are reasonable and reflect our judgment based on our knowledge and experience about past and current events, and our assumptions about conditions we expect to exist and courses of action we expect to take.
- 5. Related-party transactions, including those with other organizations for which the nature and significance of their relationship with the City are such that exclusion would cause the reporting entity's financial statements to be misleading or incomplete, joint ventures in which the City has an interest, and jointly governed organizations in which the City participates, and interfund transactions, including interfund accounts and advances receivable and payable, sale and purchase transactions, interfund transfers, long-term loans, leasing arrangements and guarantees, have been recorded in accordance with the economic substance of the transaction and appropriately accounted for and disclosed in accordance with the requirements of U.S. GAAP.
- 6. All interfund transfers have been properly approved/authorized in accordance with the City's established policies.
- 7. All events subsequent to the date of the financial statements, and for which U.S. GAAP requires adjustment or disclosure, have been adjusted or disclosed. Specifically, we have assessed and disclosed the uncertainty surrounding the financial effects of the COVID-19 coronavirus on the

- operations of the City. The extent to which the COVID-19 coronavirus may impact the results of operations will depend on future developments, which are highly uncertain and cannot be predicted at this time.
- 8. The effects of all known actual or possible litigation and claims have been accounted for as estimated by our actuary and recorded in the City's self-insurance fund and/or disclosed in accordance with U.S. GAAP.
- 9. We are not aware of any other pending or threatened litigation, claims, or assessments that are required to be accrued or disclosed in the financial statements in accordance with Governmental Accounting Standards Board Statement No. 62 and GASB Statement No.10; beyond amounts recorded in the City's self-insurance fund. There are no unasserted claims or assessments that our lawyers have advised us are probable of assertion and must be disclosed.
- 10. We have no direct or indirect legal or moral obligation for any debt of any organization, public or private, or to special assessment bond holders that is not disclosed in the financial statements.
- 11. We have complied with all aspects of contractual agreements that would have a material effect on the financial statements in the event of noncompliance.
- 12. We have no knowledge of any uncorrected misstatements in the financial statements.
- 13. The City received revenues and contributions related to grants from Federal agencies and the State of Florida. These grants are for specific purposes and are subject to review and audit by the grantor agencies. Such audits could result in requests for reimbursement for expenditures being disallowed under the grant terms. Based upon prior experience, the City's management believes any requests for reimbursement, if any, will not be significant.
- 14. In the opinion of the City Attorney, based upon the amount of damages alleged in the various cases and facts currently known, the potential liabilities associated with litigation cases will not have a material effect on City's financial statements for the year ended September 30, 2019.
- 15. We have evaluated pronouncements issued and not adopted as of the fiscal year-end and properly disclosed such pronouncements in the financial statements.

Information Provided

- 16. We have provided you with:
 - a. Access to all information of which we are aware that is relevant to the preparation and fair presentation of the financial statements such as records, documentation and other matters;
 - b. Additional information that you have requested from us for the purpose of the audit;
 - Unrestricted access to persons within the entity from whom you determined it necessary to obtain audit evidence; and
 - d. Minutes of the meetings of the governing board and committees, or summaries of actions of recent meetings for which minutes have not yet been prepared.
- 17. All transactions have been recorded in the accounting records and are reflected in the financial statements.

- 18. We have disclosed to you the results of our assessment of risk that the financial statements may be materially misstated as a result of fraud.
- 19. We have no knowledge of allegations of fraud or suspected fraud affecting the entity's financial statements involving:
 - a. Management.
 - b. Employees who have significant roles in internal control.
 - c. Others where the fraud could have a material effect on the financial statements.
- 20. We have no knowledge of any allegations of fraud or suspected fraud affecting the entity's financial statements received in communications from employees, former employees, analysts, regulators, short sellers or others.
- 21. We have no knowledge of noncompliance or suspected noncompliance with laws and regulations whose effects were considered when preparing financial statements.
- 22. We have disclosed to you all known actual or possible litigation and claims whose effects should be considered when preparing the financial statements.
- 23. We have disclosed to you the identity of the entity's related parties and all the related-party relationships and transactions of which we are aware.
- 24. We are aware of no significant deficiencies, including material weaknesses, in the design or operation of internal controls that could adversely affect the City's ability to record, process, summarize and report financial data.
- 25. We are aware of no communications from regulatory agencies concerning noncompliance with, or deficiencies in, financial reporting practices.

- 26. With respect to supplementary information presented in relation to the financial statements as a whole:
 - a. We acknowledge our responsibility for the presentation of such information.
 - b. We believe such information, including its form and content, is fairly presented in accordance with accounting principles generally accepted in the United States of America.
 - c. The methods of measurement or presentation have not changed from those used in the prior period.
 - d. When supplementary information is not presented with the audited financial statements, we will make the audited financial statements readily available to the intended users of the supplementary information no later than the date of issuance of the supplementary information and the auditor's report thereon.

- 27. With respect to the required supplementary information presented to supplement the basic financial statements:
 - We acknowledge our responsibility for the presentation of such required supplementary information.
 - b. We believe such required supplementary information is measured and presented in accordance with guidelines prescribed by accounting principles generally accepted in the United States of America.
 - c. The methods of measurement or presentation have not changed from those used in the prior period.
- 28. Expenses have been appropriately classified in or allocated to functions and programs in the statement of activities and allocations have been made on a reasonable basis.
- 29. Revenues are appropriately classified in the statement of activities within program revenues and general revenues.
- 30. We have properly reviewed and classified investments in the financial statements in accordance with the requirements of GASB Statement No. 72.
- 31. Management is not aware of any amendments or changes to the City's sponsored pension plans that are not already disclosed in the financial statements.
- 32. We agree with the results of our specialist in evaluating our self-insurance program and the estimated liability for pensions and other post-employment benefits obligation liabilities, and have adequately considered the qualifications of the specialists in determining the amounts and disclosures in the financial statements. We did not give or cause any instructions to be given to the specialists with respect to the values or amounts derived or methodology used in an attempt to bias their work and we are not aware of any matters that have had an impact on the independence or objectives of the specialists.
- 33. We believe that the actuarial assumptions and methods used to measure the City's self-insurance, other post-employment benefit obligations and the net pension liability and related costs for financial accounting purposes are appropriate in the circumstances.
- 34. On April 6, 2017 the City entered into an agreement for the purchase and sale of property with a developer. In connection with the agreement, the City purchased and took possession of the Minorca land parcel from the developer as of September 30, 2018. The agreement provides the developer with the option to (1) pay \$5.2 million to acquire the City owned Salzedo land parcel and received \$2 million in impact fee credits or (2) require the City to pay \$11.5 million to complete the transaction. As of the date of this letter, the City expects that developer to exercise its option to pay \$5.2 million to acquire the City owned Salzedo land parcel and received \$2 million in impact fee credits to complete the transaction by February 23, 2021, as required by the agreement. In September 2019, the City adopted Ordinance 2019-29 approving the third amendment to the agreement to provide for additional land exchange terms in the event the Developer elects, in the exercise of its sole discretion, to acquire certain parcel of real property (Valencia/Almeria Parcels) and convey the Salzedo land parcel to the owner of Valencia/Almeria land parcels. The proposed closing date for this transaction was extended to February 23, 2021.
