A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE PROCUREMENT OFFICER TO AWARD THE CONTRACT FOR PUMP STATIONS SCADA/TELEMETRY SYSTEM REHABILITATION TO CUSTOM CONTROLS TECHNOLOGY, INC., AS THE LOWEST RESPONSIVE AND RESPONSIBLE BIDDER IN THE AMOUNT OF \$835,180.01, PURSUANT TO INVITATION FOR BIDS (IFB) 2019-046 AND SECTION 2-763 OF THE CITY'S PROCUREMENT CODE ENTITLED "CONTRACT AWARD".

WHEREAS, on December 2, 2019, the Procurement Division of Finance formally advertised, issued and distributed the IFB for Pump Stations SCADA/Telemetry System Rehabilitation; and

WHEREAS, on December 10, 2019, a non-mandatory pre-bid meeting and site visit was held with two (2) prospective firms in attendance, and

WHEREAS, thirty-three (33) prospective bidders downloaded the IFB package from Public Purchase, the City's web-based e-Procurement service; and

WHEREAS, on January 31, 2020, three (3) bids were received in response to the IFB 2019-046 from: Control Instruments, Inc. (C2i); Custom Controls Technology, Inc. and Revere Controls, Systems, Inc., and

WHEREAS, the Public Works Department concurs with the Procurement Officer's recommendation to award the Pump Stations SCADA/Telemetry System Rehabilitation contract to Custom Controls Technology, Inc. as the lowest responsive and responsible bidder, and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

That the City Commission accepts the recommendation of the Procurement Officer to award the Pump Stations SCADA/Telemetry System Rehabilitation contract to Custom Controls Technology, Inc. as the lowest responsive and responsible bidder to provide the services in an amount of \$835,2180.01 for a period of three (3) years with two (2) one (1) year options to renew, and approve additional spending authority for the purchase of additional support and software licenses in an amount not to exceed the available budget, pursuant to Invitation for Bids (IFB) 2019-046 and Section 2-763 of the Procurement Code entitled "Contract Award"

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
