been (INAUDIBLE) insurance marketplace worldwide and specifically in Florida had become

extremely challenging, driven by double-digit rate increases, lack of capacity and lack of available

markets willing to assume risk. The challenge becomes exponentially greater when it comes to

ensuring municipal accounts and specifically those with the uniqueness of a City like Coral Gables.

It's important to be aware the current trends and rate increases are expected to continue for the

following year. We must continue to support excellent risk management practices and do

everything we can to keep losses at a minimum. I understand that Gallagher would like to bind
