so we could combine them both then you have the -- one is -- one -- B-5 is for miscellaneous

City Manager Iglesias: Excuse me. I thought I lost you. B-5 is for miscellaneous furniture that

goes in the office -- and also -- and again, we would like to get this order in as soon as possible to

minimize any delays as far as the Public Safety Building. So, with B-4 and B-5, we should be in

good shape as far as the furniture is concerned and see if we can certainly move in as quickly as

possible. I think with what's happened and with hurricane season coming, I would like to get into

that building as soon as possible.

Vice Mayor Lago: Yeah. Peter, if you -- just a quick question on my end. What are we looking

at in regard to lead times because -- and also for the delivery of the building so those coincide

well?

City Manager Iglesias: The delivery of the -- I'm sorry, Celeste, please (INAUDIBLE).

Assistant Finance Director Walker: The delivery -- initially, when we solicited the solicitation,

they responded back that it would be eight weeks. So, now with the new global issue, we will be

addressing them as soon as this item passes to see what impact it has on the delivery and the initial

timelines they gave us. But initially, it was eight weeks.

Vice Mayor Lago: Yeah, because that's my concern. I mean, obviously, like you mentioned, it's

a global issue and a lot of this furniture that I'm aware of is not -- some of it's not made here in

the United States. So, you know, I think -- that's another conversation for another day that

hopefully we're putting on the agenda. But I think this is something that we need to look at here,

especially as things slow down on a global level in regard to actually imports coming into the

United States. So, I just wanted to put that on the record and make sure that we monitor that as

much as possible.

Mayor Valdes-Fauli: Thank you.

City Manager Iglesias: Our -- Vice Mayor, our current delivery (INAUDIBLE), we're looking --

we were looking at the end of September, beginning of October. So, if this order instead of eight

weeks is sixteen weeks, then I think we can still work with that. I do expect some delays because

we haven't had the full staffing at the Public Safety Building. And however, even if we double the

delivery time, we still should be okay for a TCO some time in -- during that time. It's -- we haven't

really adjusted the schedule yet. I haven't wanted to do that, so -- until we get a better
