RESOLUTION OF THE CITY **COMMISSION** AUTHORIZING THE PROCUREMENT OFFICER TO WAIVE THE COMPETITIVE PROCESS TO PURCHASE VISUAL COMPUTER SOLUTIONS' OMS PLATFORM MAINTENANCE SERVICE AS Α "SPECIAL WAIVER." **PURSUANT** PROCUREMENT/BID TO SECTION 2-691 OF THE CITY'S PROCUREMENT CODE.

- WHEREAS, the Information Technology Department (ITD) purchased the Visual Computing System Platform in February 2015 to operate Police Off-duty Scheduling (POSS) and Attendance Systems (TIMES); and
- WHEREAS, the Visual Computer Solutions system supports the electronic processes for Police Off-Duty Scheduling and Attendance and is used by all sworn personnel admin staff for scheduling and OT tracking; and
- WHEREAS, the IT Department has the need to renew the annual maintenance of the OMS Platform for a period of three (3) years at \$29,270 each year; and
- WHEREAS, the City is seeking approval to purchase the on-going maintenance for the existing Visual Computer Solutions system that includes coverage for the domain subscription, cloud services, hosting fees and user tools; and
- WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

- **SECTION 1**. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
- **SECTION 2.** That the City Commission accepts the recommendation of the Procurement Officer and authorizes the City Manager to purchase Visual Computer Solutions' OMS Platform annual maintenance service, pursuant to Section 2-691 of the City's Procurement Code.
