Mayor Valdes-Fauli: Yes.

City Attorney Ramos: F-4 is an ordinance of the City Commission of Coral Gables, Florida, providing a text amendment to the City of Coral Gables Zoning Code, Article 3,"Development Review", Section 3-606 to include Dade Heritage Trust, Inc. as a party that can appeal decisions that the Historic Preservation Board; providing for a repealer provision, severability clause,

codification, and providing for an effective date. Mr. Ceballos.

Assistant City Attorney Ceballos: Good afternoon, again. So, as -- if you can recall, this item came before you slightly varied. It was originally going to be an aggrieved party definition that was going to be modified in our Code to allow for Dade Heritage Trust. Following the request of the Commission, we've modified that. I've brought it back on first reading because it's such a significant change from the first reading. So, this one was basically -- as described, it amends 3-606, creates a small carve out that allows Dade Heritage Trust, only Dade Heritage Trust, to be considered a party that may file an appeal of a decision of the Historic Preservation Board. It went before Planning and Zoning a little bit out of turn. It wouldn't before. Planning and Zoning voted 4-2 against Dade Heritage Trust being added. They predominantly were just concerned that it may open up a can of worms allowing Dade Heritage Trust. Maybe other individuals and other parties would be allowed as a party, and they were concerned about it and their recommendation was to deny. If you have any questions, please let me know.

Mayor Valdes-Fauli: I agree with that. And why Dade Heritage Trust? I mean, yes, they have the expertise, but they don't have the knowledge of Coral Gables history, Coral Gables tradition, Coral Gables, whatever. And they may be from North Miami Beach and from wherever. I am against any changes that take the authority, power and dignity away from our Historic Preservation Board. We do a very good job choosing the right candidates in the right professions in our Historic Preservation Board. And allowing appeals other than our staff and Commission, I guess, other

than that makes us the Historic Preservation Board and I don't think that that's our proper role.

And I think that soils the authority of the Historic Preservation Board.

Vice Mayor Lago: Mayor, before I make any comments, I'd like to see if Kara would like to come

up and just give us her opinion in regards to that. The good, the bad, and the ugly. What is your

opinion? Talk to me a little about why this is something that you think would be of good business

for the City.

Assistant Historic Preservation Officer Kautz: Well, there are -- we had chosen Dade Heritage

Trust -- and I brought this up at the last -- when this came up the first time -- because they are a

long-standing organization that's staffed by professional staff as opposed to some of the other

volunteer organizations. Yes, their board is made up of volunteers, but they do have professional

staff on board that provides a point and counterpoint to every issue that's brought before them,

which is why we narrowed it down to that organization.

Mayor Valdes-Fauli: Yeah, but we did that as a compromise and allowing somebody to appeal.

But that wasn't the initial proposal at the time.

Assistant Historic Preservation Officer Kautz: Correct. I'm...

City Attorney Ramos: You should also remember that aggrieved parties, anyone within a thousand

feet, can also appeal already as it stands.

Assistant Historic Preservation Officer Kautz: Correct. And that is the standing -- and I believe

part of the discussion when this was at the Commission last time was that the portion that you were

also considering changing was the time period that staff had after an appeal had lapsed. So, I think

as a matter of process moving forward, we will take the appeal role forward as opposed to, you

know, just waiting for someone in the public to do so.

were tasked with choosing someone, right?

Assistant Historic Preservation Officer Kautz: Well, it was the recommendation of Dona's, yes,

so I'm taking it forward on her stead.

Commissioner Fors: What about the general idea of granting standing to somebody outside or an

organization outside of...

Assistant Historic Preservation Officer Kautz: Other municipalities have it both ways. I think the

City of Miami has language in their Code that talks to any organization -- 501(c)(3) organization

that has preservation as its mission or in its mission statement. We were just being more specific

than that. Cities like Savannah and Charleston, which were the two that were included in your

packet, their appeals state that it's just any aggrieved party, much like ours is now. So, it goes both

ways. You can have it either way.

Assistant City Attorney Ceballos: And the original inter -- the original version that came before

you last meeting was specifically in line with the Miami one, and I also just want to make sure that

something is clear. The 72 hours, the additional window, that already got approved on first reading

Vice Mayor Lago: Listen, I think what it ends up having is another set of eyes and ears who are qualified, who are much more qualified than I am in regards to historic preservation and I think

the Commission is. Even though we may be the final arbiter on this matter or whatever may be

presented before us, I think it's just another set of eyes and ears that are qualified. They can give

us their opinion in reference to certain property that should be or should not be designated as

historic. I don't have any issue with it. I mean, obviously, that's why I sponsored it -- cosponsored

it with Commissioner Mena.

Commissioner Keon: Yeah. I don't think that -- I agree with the Mayor. I don't think Dade

Heritage Trust needs to be on there either. I think as long as staff and any -- as long as we added

staff, that's adequate to ensure that we don't get into the same situation that we did before. You

know, I think Dade Heritage Trust has a purview over Miami-Dade County, where I think that

threatened is where they tend to move. It doesn't preclude any of the local organizations from, you

know, pairing with them to take things forward. So, the Villagers or Historic Preservation

Association maybe don't have the resources or the staff support or the professional support, they

could partner with Dade Heritage Trust to, you know, bring an appeal forward. It doesn't preclude

any of the local groups from doing that. It's just a mechanism through which they could do an

appeal.

Vice Mayor Lago: Do you and your department view -- and again, because I'll remove it. I'll

remove the language obviously from the ordinance. But do you believe that Dade Heritage Trust

brings value as an opportunity here to get involved?

Assistant Historic Preservation Officer Kautz: I do. They're a well...

Vice Mayor Lago: Because I...

had mentioned before...

Vice Mayor Lago: But even though they've -- even though they're involved throughout my Miami-

Dade County, do you believe that they have specific knowledge of our background, of our specific

background and how important -- George Merrick's vision, you know...

Assistant Historic Preservation Officer Kautz: Absolutely.

Vice Mayor Lago: Fink, all the important...

Assistant Historic Preservation Officer Kautz: Yeah. Their memberships...

Vice Mayor Lago: Individuals.

Assistant Historic Preservation Officer Kautz: Our -- two of our board members, current board

members, are on their board currently. Dona Spain, who (UNINTELLIGIBLE), is on their board

and set to be president, I believe, next year.

Vice Mayor Lago: Oh, okay.

Assistant Historic Preservation Officer Kautz: So, they are -- they do know what's going on here.

So, it's not like they're operating in a void.

Commissioner Mena: I liked the -- I personally like the fact that it's not an exclusively sort of
