City Clerk Urquia: Mr. Mayor, just to...

for the City during this very critical time. I wanted to check in. I've heard the concerns about

testing, concerns that many of us here in the Delegation share as well as we contemplate reopening,

but not just a public health and economic crisis but a crisis of confidence, really, one way to kind

of tamp down the concerns of the community as well as to the visiting public that we need to come

back to Florida (INAUDIBLE) and make sure that we get more widespread testing and limit the

transfer of community spread that may or may not exist across Florida. I just quickly wanted to

highlight we are trying to work with your staff on FEMA reimbursements. Understand that the

general fund, because of this crisis, is under great stress. I want to thank Commissioner Keon for

keeping me abreast of what is still outstanding in terms of account receivables of the City. And

we are in communication with Director Moskowitz and his staff to try to get the balance of funding

forwarded to you. If there are any other priorities or issues that are outstanding where I or the state

could be helpful in the months and weeks going forward, please don't hesitate to reach out. Again,

I'll leave my comments at that because I have to jump off to another call here, but if there's

anything pressing that we can quickly touch base on, I'm happy to do that now or we can follow

up individually.

fine representation. Thank you.
