Labor Relations and Risk Management Director Elejabarrieta: Sure. Good morning, everyone, again. So, before you is an ordinance amending the City's pension plan so that it complies with the Secure Act. The Secure Act was signed into law December of 2019. And basically, it increases the minimum age -- I mean, the age requirement to obtain the required minimum fund contribution. It's currently 70 and a half, and it increases it to 72. So, this ordinance simply amends our pension plan so that it complies with the Secure Act.
