RESOLUTION 2020 -163

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING AN AMENDMENT TO THE FISCAL YEAR 2019-2020 AMENDED BUDGET TO RECOGNIZE, AS REVENUE, A TRANSFER OF \$480,000 FROM THE IMPACT FEE FUND AND TO APPROPRIATE SUCH FUNDS FOR SPECIAL TRAFFIC SIGNALIZATION WORK REQUIRED AT THE NEW PUBLIC SAFETY BUILDING; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, staff has identified a need for special traffic signalization work for the New Public Safety Building at the mid-block of Alcazar Ave and the intersections at Salzedo St. and Alcazar Ave, Ponce De Leon Blvd. and Alcazar Ave; and

WHEREAS, the additional work is necessary to control traffic and facilitate the unobstructed exit of fire and rescue vehicles during an emergency; and

WHEREAS, the special signalization work will take place to control east and westbound traffic thereby allowing Fire Department vehicles to exit the station's apparatus bay free of traffic; and

WHEREAS, in compliance with Ordinance 2007-27 as well as the revised impact fee schedule as approved by Resolution 2017-67, the City collects various impact fees to help fund capital improvement projects that qualify as enhancing services for residents, business owners and visitors; and

WHEREAS, staff is recommending the use of mobility impact fees to cover the \$480,000 cost of this work; and

WHEREAS, an amendment to the Fiscal Year 2019-2020 Annual Budget is required to recognize as revenue a \$480,000 transfer from the Impact Fee Fund and to appropriate such funds to put toward the cost of the special signalization work;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "WHEREAS" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. The City Commission authorizes an amendment to the Fiscal Year 2019-2020 Annual Budget to recognize as revenue a \$480,000 transfer from the Impact Fee Fund and to

appropriate such funds to put toward the cost of the special signalization work.

SECTION 3. All Resolutions or parts of Resolutions, insofar as they are inconsistent or in conflict with the provisions of this Resolution, are hereby repealed.

SECTION 3. That this Resolution shall become effective upon the dated of its passage and adoption herein.
