RESOLUTION NO. 2020-153

A RESOLUTION APPROVING A PUBLIC ART EXHIBITION BY KIKI SMITH, AND FOR APPLICATION TO ART BASEL, EXTENDING THROUGH WINTER, 2020-2021 (UNANIMOUSLY RECOMMENDED BY THE ARTS ADVISORY PANEL APPROVAL/DENIAL VOTE: 7 TO 0, AND THE CULTURAL DEVELOPMENT BOARD APPROVAL/DENIAL VOTE: 7 TO 0).

WHEREAS, the Cultural Development Board historically has recommended City participation in Miami's Art Week and, more specifically, an affiliation with Art Basel; and

WHEREAS, it's understood that Art Basel may present itself in a different format this year, it's important for the City to maintain quality programming that invites residents and visitors to confidently and safely experience the arts within the City Beautiful; and

WHEREAS, in partnership with the curatorial team of Fung Collaboratives, and to further the new arts initiative of Illuminate Coral Gables, the City requested a proposal for a temporary exhibition of artwork by renowned artist Kiki Smith; and

WHEREAS, the artist developed a proposal for artwork at Giralda Plaza; and

WHEREAS, building on the established relationship with Art Basel, the City proposes to submit an Art Basel VIP event application to celebrate the exhibition; and

WHEREAS, funding for the temporary exhibition is estimated at \$200,000 (two hundred thousand dollars) and related support is estimated at \$50,000 (fifty thousand dollars) through use of the art acquisition fund; and

WHEREAS the Arts Advisory Panel voted unanimously (7-0) to recommend Kiki Smith and her proposed project for a temporary public art exhibition and Art Basel special event artist at their meeting on June 24, 2020; and

WHEREAS, the Cultural Development Board voted unanimously (7-0) to recommend Kiki Smith and her proposed project for a temporary public art exhibition and Art Basel special event artist at their meeting on July 7, 2020;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES AS FOLLOWS:

SECTION 1. That the foregoing "Whereas" clauses are here hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby approve a public art exhibition by Kiki Smith, submission of the exhibition to Art Basel as an official event and funding up to \$250,000 (two hundred fifty thousand dollars) from the Art Acquisition Fund.

SECTION 3. That this resolution shall become effective upon the date of its passage and adoption herein.
