Vice Mayor Lago: So, moving up to F-5, I would really appreciate it if my colleague would support me on this resolution, which I'll be requesting funds from the TPO and SUN Trail funds, additional funds that are potentially going to be available to finish up, like ACM Santamaria mentioned, the Old Cutler Trail bicycle path, which has been in discussions for over 16 years.

Like I mentioned, it's a three-quarter to a one-mile bike path, which would ensure pedestrian and

bicycle safety on Old Cutler. And I think that it's long overdue and it's something that we need to

deliver to the residents and to the people who bike through our community, so I make a motion.

Mayor Valdes-Fauli: Any comments?

Commissioner Keon: Well, I would -- yeah, certainly.

Commissioner Keon: I think that, you know, a lot of money was just allocated to the Commodore

to -- that looks like it seems to be replacing the sidewalks in the Grove. That -- you know, because

a lot of people still use -- they stay on Old Cutler and don't go through -- I mean, some go through

Snapper Creek, but a lot of them just say (INAUDIBLE) trail and connect directly through Old

Cutler to Red Road. And where the bridge goes over the Snapper Creek Canal along Old Cutler

is very narrow and exceedingly dangerous for (INAUDIBLE) and pedestrians, so it -- they need

to continue the trail, and they need to add the pedestrian access bridges on each side of the existing

bridge or replace the bridge on the Snapper Creek Canal.

Vice Mayor Lago: So, Commissioner...

Commissioner Keon: (INAUDIBLE) is (INAUDIBLE).

Vice Mayor Lago: Second the motion.

Commissioner Keon: Yes, I second it. No, it's very dangerous that (INAUDIBLE) for pedestrians

and for bicyclists.
