City Attorney Ramos: G-2 is a resolution of the City Commission of Coral Gables, Florida, adopting rules of procedure for virtual meetings for the Coral Gables Board of Architects during the pendency of the State of Emergency that we're currently in. As the Commission knows, we adopted Rules of Procedure, which were required by the Governor's executive order for this Commission and for all boards and committees of the City several months ago, both for regular meetings and for quasi-judicial meetings. But as we resume more and more our normalcy, we're having some boards that are a little bit more complex, having the need for additional rules. Board of Architects is one of them, Construction Regulation's is another, Code Enforcement's is another. For some reason, the City Code requires that any Board of Architects rules be adopted by this Commission, as well as by the Board of Architects, so that's why they're here for ratification by you.

Mayor Valdes-Fauli: Do I hear a motion?

Vice Mayor Lago: So moved.

Commissioner Mena: Second.

Vice Mayor Lago: Mayor, before we...
