RESOLUTION NO. 2020-220

A RESOLUTION OF THE CITY COMMISSION ACCEPTING THE RECOMMENDATION OF THE CULTURAL DEVELOPMENT BOARD TO APPOINT ADLER GUERRIER TO THE ARTS ADVISORY PANEL TO SERVE FOR THE REMAINDER OF A TWO (2) YEAR TERM, WHICH BEGAN ON JUNE 1, 2019 AND CONTINUES THROUGH MAY 31, 2021. (UNANIMOUSLY RECOMMENDED BY THE CULTURAL DEVELOPMENT BOARD APPROVAL/DENIAL VOTE: 5 TO 0).

WHEREAS, The Arts Advisory Panel is comprised of nine (9) members, with the Cultural Development Board recommending seven (7) members' appointment to the City Commission; and

WHEREAS, there is a current vacancy on the Arts Advisory Panel; and

WHEREAS, On September 1, 2020 the Cultural Development Board voted to recommend appointment of a new member to the Arts Advisory Panel; and

WHEREAS, the following recommended appointee has agreed to serve Adler Guerrier;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a part of this resolution upon adoption hereof.

SECTION 2. That the City Commission does hereby appoint Adler Guerrier as a member of the Arts Advisory Panel for the remainder of a two (2) year term, which began on June 1, 2019 and continues through May 31, 2021.

SECTION 3. That this Resolution shall become effective immediately upon the date of its passage and adoption herein.
