SUBJECT: Award Recommendation RFP 2020-005 Fitness Program Management Services

At the November 17, 2020 City Commission Meeting an award recommendation for RFP 2020-005 Fitness Program Management Services will be included on the agenda. This memorandum serves to notify you that in accordance with Section 2-763 of the City Code entitled "Contract Award", my recommendation to the City Commission for award of the subject RFP is as follows:

- Accept the recommendation of the Procurement Officer to award the RFP contingent upon fee negotiations with The Fitness Center, Inc., the responsive and responsible proposer, for Fitness Program Management Services.
- 2) Reaffirm the City's right to pursue alternative courses of action.

On August 12,2020, the Procurement Division of Finance formally advertised, issued, and distributed Fitness Program Management Services, Request for Proposals (RFP) 2020-005. Fifteen (15) prospective proposers downloaded the RFP package from Public Purchase, the City's web-based e-Procurement service.

On September 14, 2020, two (2) firms submitted proposals in response to the RFP: Breakout Performance and Physical Therapy, LLC and The Fitness Center, Inc.

The responses were reviewed by the Procurement Division in order to determine responsiveness to the requirements of the RFP. During the review, it was determined that the following proposer would be deemed non-responsive and would receive no further consideration for award: Breakout Performance and Physical Therapy, LLC (proposer failed to meet the minimum qualifications for the RFP);

On October 9, 2020, the Evaluation Committee convened to evaluate the responsive and responsible proposal. The Evaluation Committee determined that The Fitness Center, Inc., was a responsive-responsible proposer for the contract award.

The Evaluation Committee further recommended to award the contract contingent upon fee negotiations with The Fitness Center, Inc. Should the negotiation fail, the City will proceed with options in the best interest of the City.

After successful negotiations, a Professional Services Agreement will be executed. A more detailed description of the RFP, proposal response and evaluation results will be provided to you as part of the Agenda package.
