# D. AGENDA ITEMS

## D-1 University COVID-19 Update, Maite Alvarez

- •Webpage on university's main site has all COVID related information.
- •Testing all students every two weeks.
- •Also providing random testing of employees.
- •Facilities department has provided signage and A-frames at all buildings and entrances.
- Utilizing several large spaces on campus to adhere to social distancing standards.
- •Currently, there are: 3800 students living on campus, 5300 students that are 'off', 3700 students that are completely remote.

#### D-2 Update on the University's Events, Maite Alvarez

- •All events that concern partners/external parties have been cancelled until at least January and there are no indoor events until at least November.
- •Following social distancing.
- •Planning safe outdoor celebrations.
- More traditional homecoming will be held in the Spring.

#### D-3 Update on the University's Planning & Construction Initiatives, Alicia Corral

Update provided by Ricardo Herran.

- •Lakeside Village was completed and open to resident students in the fall and includes amenities by the lake.
- •Will be demolishing the 'old house center' to create a more direct connection into the garage by Lakeside Village.
- •Student services center was also completed- across from the business center.
- •Intermural fields were completely redone.
- •Parking lot adjacent to the fields was removed.
- •Completed a green house behind the physics building.
- Completed indoor batting facility for baseball.
- •Second phase of student housing has been delayed a bit but are moving forward with preparation.
- •Frost School of Music- night recital hall will be constructed- site work is beginning.

# D-4 Update by the University's Police Department, Chief David Rivero

- Crime rate is down due to COVID.
- •33 crimes this year- lowest crime year since 1989.
- •Concentrating on COVID precautions- mask wearing enforcement.
- •Fully staffed- only have had two COVID cases out of 55 employees. Those two employees have since recovered and are back at work.

#### D-5 Update by the University's Vice President of Student Affairs, Dr. Patricia A. Whitely

- •Have begun doing outdoor activities.
- •Wellness center is only open to students.
- •Mandatory testing for resident students every 10 days.
- ·Administering flu shots.
- •Going through five testing protocols through November 11th.
- Working on mental health awareness especially for students who have been quarantined.
- •Students have been complying for the most part.

#### D-6 Update by the University's Interfraternity Council President

Update given by Paula Spada on behalf of Board Member Milano.

- •Sigma Alpha Mu will be celebrating its 75th year since initial chartering
- •ISC did not have an official recruitment period in order to be safe in lieu of COVID but will start doing some recruitment in the Fall.

#### D-7 Update by the University's Student Government President

- •Finding creative solutions to communicate with students about COVID-19.
- •Moral on campus is high.
- •Working on racial justice initiatives as well as LGBTQ initiatives.
- •Arranging safe voter initiatives in order to get students to vote.
