3. PAGE A-1.0 PROPOSED SITE PLAN, PROVIDE THE LENGTH OF THE PROPERTY LINES.

4. PAGE A-2.0, PROVIDE THE LENGTH OF THE ROOF OVERHANG PROJECTION. ARTICLE 5, SECTION 5-1609.

5. PAGE A-1.0 PROPOSED SITE PLAN, PROVIDE THE ROOF OVERHANG.

6. PAGE A-1.0, PROVIDE THAT THE DRIVEWAY AND APPROACH HAVE THE SAME WIDTH, LABEL AND DIMENSION ACCORDINGLY (SEE PLANS FOR CLARIFICATION). ARTICLE 4, SECTION 4-101, D., #13.

7. PAGE A-1.0, PROVIDE THE 45% GROUND AREA COVERAGE CALCULATION. ARTICLE 4, SECTION 4-101, D., #8.

8. ON THE FINAL PERMIT APPLICATION PLAN SUBMITTAL, IN ADDITION TO THE GROUND AREA COVERAGE CALCULATIONS (35% & 45%), INCLUDE, A DIAGRAM OF THE BUILDING FOOTPRINT AND INDICATE ALL THE AREAS THAT WERE COUNTED, THEIR SQUARE FOOTAGE, AND INCLUDE ANY ACCESSORIES IF APPLICABLE. ZONING CODE ARTICLE 4, SECTION 4-101, D., #8 (NOTE, PAGE A-1.0 PROPOSED AREA DIAGRAM ONLY PROVIDES THE FLOOR AREA RATIO SQUARE FOOTAGE).

9. PAGE A-1.0 PROPOSED SITE PLAN, PROVIDE THE LOCATION OF THE DOUBLE GATES, LABEL ACCORDINGLY.

10. PAGE A-1.0, RELABEL THE "COVERED ENTRY" TO "ENTRY WITH OVERHANG" (IF NOT THE COVERED ENTRY WILL BE CALCULATED TO THE GROUND AREA COVERAGE 35% AND 45% CALCULATIONS).
