LETTER OF INTENT FOR THE IRAHETA RESIDENCE APPLICATION 2806 GRANADA BVLD. CORAL GABLES

This application seeks approval for the following described work to the existing historic residence located at 2806 Granada Boulevard.

The work includes three additions and a proposed new pool and associated remodeling and site work.

The first addition is an extension of the existing second floor master suite over the terrace on the south end of the residence. The sunroom below would be enclosed as well. The existing openings and iron work on the ground floor will be retained.

The second addition is a new entry way connecting the living room and dining room with the rear garden. It sits in the cleft between the two wings of the existing residence.

The third area is to the west end of the property. This includes a new garage to accommodate two cars and a two story addition extending he residence along the De Soto elevation. Due to the irregular shape of the lot, we are seeking a variance to reduce the setback from the western rear property line from 10'-0" to 5'-0".

We feel that the granting of these requests will allow the development of the residence in a manner that is harmonious with the area.
