ZONING OBSERVATIONS REQUIRING CITY ARCHITECT OR BOARD OF ARCHITECTS SPECIFIC APPROVAL AS PER THE ZONING CODE

1. BALCONY WILL NOT BE ALLOWED TO PROJECT INTO THE REQUIRED SETBACKS. AS PER ZONING CODE ARTICLE 4, SECTION 4-101, #4, A, PARCEL HAS A MINIMUM TWENTY-FIVE (25) FOOT FRONT SETBACK. THE BOARD OF ARCHITECTS MAY RECOMMEND APPROVAL OF VARIANCES TO THE BOARD OF ADJUSTMENT OR THE HISTORIC PRESERVATION BOARD, AS APPLICABLE.

GENERAL OBSERVATIONS

- 1. BALCONY WILL NOT BE ALLOWED TO PROJECT INTO THE REQUIRED SETBACKS. AS PER ZONING CODE ARTICLE 4, SECTION 4-101, #4, A, PARCEL HAS A MINIMUM TWENTY-FIVE (25) FOOT FRONT SETBACK.
- 2. PREVIOUS PERMIT NUMBER BL-15-06-5906, SHOWED APPROVED POOL AT TEN (10) FEET FROM THE REAR PROPERTY LINE AND POOL DECK AT FIVE (5) FEET. POOL DECK ON PLANS DOES NOT MATCH PREVIOUSLY APPROVED DESIGN. NEED TO MATCH PREVIOUSLY APPROVED OR INDICATE NEW AREAS TO BE ADDED, ANY NEW AREA WILL NEED TO COMPLY WITH SETBACKS AND LANDSCAPING.
- 3. PREVIOUS PERMIT NUMBER 97120445 SHOWED MECHANICAL EQUIPMENT BEING RELOCATED OUT OF THE REQUIRED SETBACKS. AS PER ZONING CODE SECTION 5-1804, #4, ALL MECHANICAL EQUIPMENT SHALL COMPLY WITH REQUIRED SETBACKS OF THE BUILDING SITE. NEED TO ALSO SHOW LOCATION OF POOL EQUIPMENT.
- 4. AS PER SECTION 5-1301, ALL PORTIONS OF EXTERIOR WALLS, INCLUDING INTERIOR WALLS OF GARAGES, ROOMS EXCEEDING TWENTY-FIVE (25) SQUARE FEET IN AREA WHICH LIE WITHIN A GARAGE, SHALL BE OF THE SAME TYPE CONSTRUCTION AS THE MAIN WALLS OF THE BUILDING AND PROPERLY TOPPED WITH TIE BEAM OR RAKES. NEW WALL IN GARAGE MUST BE 8" MASONRY.

- 5. AS PER SECTION 5-1402, A MINIMUM CLEARANCE OF NINE (9) FEET BY EIGHTEEN-AND-A-HALF (18.5) FEET MUST BE MAINTAINED WITHIN GARAGES TO SATISFY THE REQUIREMENTS FOR STORAGE OF ONE (1) VEHICLE. PLANS MUST SHOW DIMENSION.
