**RESOLUTION NO. 2019-271**

A RESOLUTION OF THE CITY COMMISSION DIRECTING THE CITY MANAGER TO DESIGN AND FACILITATE PUBLIC INPUT REGARDING THE OPEN SPACE ON BLUE ROAD BY END OF YEAR, 2020.

**WHEREAS**, the open space on Blue Road is a beautiful, city-owned piece of property on the City of Coral Gables waterway; and

**WHEREAS**, the open space on Blue Road must be modified to avoid safety issues as there is a waterway adjacent to the space at hand; and

**WHEREAS**, currently albeit city-owned property, the property exhibits a “No Trespassing” sign preventing city residents to enjoy the space; and

**WHEREAS**, city residents have continuously inquired about the open space on Blue Road and whether it is accessible to residents;

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:**

**SECTION 1.** That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.




