Commissioner Keon: Can I just talk for one second. This is for the public's interest. The company, Bahama Petroleum Company, where they are first setting up is only about 150 miles off of the Florida coast to begin for oil exploration. And they have been granted licenses by the Bahamian Government to explore 4 million acres of the Bahamas. It is an extensive, extensive exploration and potential site for oil drilling in the Bahamas, which is one of our most pristine waters that we have in this area of the world, and the concerns of oil spills are real, and we have seen them around the world. So, I think its very important that we as a community keep track of what is happening here. I think the issue went before the Bahamian Supreme Court just recently and I don't know what the – preservation groups brought it to the Supreme Court to try and stay the drilling. I don't know what the result is yet. I thought it was last week, they went, and I don't know the result. But I think its important that we keep an eye on and we help those that are looking to protect those waters to protect them. Thank you. That's all.

Mayor Valdes-Fauli: Thank you. Thank you, Commissioner. It is very, very important and everybody says that they have the utmost precautions and its failsafe, and nothing is going to happen, and I call attention to what happened in the Gulf of Mexico with...Petroleum

Commissioner Keon: Deep Water Horizon.

Mayor Valdes-Fauli: And we are still not over the disaster, billions of gallons of raw oil were poured there and if that happens in these pristine waters, as you say, I think it would be an environmental catastrophe. There is nothing we can do about it, except urge them to consider the consequences of any disaster in offshore drilling exploration and licenses giving. Thank you.
