Good morning, I am writing to follow up on the permit process. Is the property going to be physically inspected to determine if the permit coded size of the structure is accurate?

I have also included photos which show that the screening is not complete. I was under the impression that the screening was supposed to be by landscaping, not by black panels and mesh. My neighbor has put up some black paneling and some mesh screening material, however as you can see, my view of the structure and their view to my bedroom from the balcony is still clearly unobstructed and unscreened.

Additionally, it looks like the size that you were quoted are less than the house portion of the structure, however that does not account for the platform which is an integral part of the structure as well as the stairs. The platform base of the structure measures approximately 14 feet in length along the side, not counting the stairs. Adding the stairs totals approximately 20 feet. I have included a video that shows the length of the platform as seen from my yard as well as pictures below of the inadequate screening.

Please update me on this process. We are now approaching three years that this issue has been ongoing.

Yes, the plans received a rejection (hold) from zoning. The proposed plans did not have all the information needed to determine if it complied with the requirements of the Ordinance. In addition, it was missing required screening, the location appeared to be incorrect, and the plans did not have dimensions to verify compliance.

Here is a copy of the comments placed by zoning on 01/12/2021.

AS PER ORDINANCE 2020-33 PLAYHOUSE SHALL:

1. PLAYHOUSE SHALL NOT EXCEED SIXTY (60) SQUARE FEET. NEED TO SHOW DIMENSIONS OF PROPOSED PLAYHOUSE.

3. SHALL BE SCREENED BY LANDSCAPE OR WALL TO OBSCURE THE VIEW FROM THE NEIGHBORING PROPERTIES. 4. PARCEL IS PLATTED FACING CALATRAVA, DIRECTLY BEHIND WILL BE THE REAR (TEN (10) FOOT REAR SETBACK REQUIRED). PLAYHOUSE IS SHOWN AT FIVE (5) FEET FROM THE REAR VS. THE TEN (10) FOOT REAR SETBACK REQUIREMENT. 5. IF SCREENED FROM NEIGHBORING PROPERTIES, THE SETBACK MAY BE REDUCED TO TWO 2) FEET SIX (6) INCHES. 6. SHALL NOT BE PLAINLY VISIBLE FROM ANY PUBLIC STREET OR PUBLIC RIGHT OF WAY.
