ZONING OBSERVATIONS REQUIRING CITY ARCHITECT OR BOARD OF ARCHITECTS SPECIFIC APPROVAL AS PER THE ZONING CODE

- 1. PLANS INDICATE "EXISITING WOOD FENCE TO REMAIN", AS PER PREVIOUS PERMIT NUMBER BL-15-06-5906 THIS WAS A CHAIN LINK FENCE. NEED TO PROVIDE PERMIT NUMBER FOR WOOD FENCE, IF NO PERMIT IS FOUND THEN WOOD FENCE WILL NOT BE ALLOWED.
- 2. AS PER SECTION 5-502, A, #3, A FLAT ROOF WITHOUT A PARAPET WILL NOT BE ALLOWED IF VISIBLE FROM THE FRONT ELEVATION. NEW CONCRETE EYEBROW TO BE APPROVED BY BOARD OF ARCHITECTS.
- 3. AS PER SECTION 5-502, A, #2, THE FLAT ROOF PORTION SHALL NOT EXCEED FIFTEEN (15%) PERCENT OF THE GROUND AREA OF THE BUILDING.

GENERAL OBSERVATIONS

- 4. AS PER SECTION 3-308, E & F, PLANS MUST SHOW A COMPLETE POOL ENCLOSURE. NEED TO SHOW WALL OR FENCE AT SIDES AND REAR.
- 5. WHEN MORE THAN ONE PLATTED LOT IS INVOLVED A UNITY OF TITLE MUST BE FILED WITH THE CITY ATTORNEY'S OFFICE. AS PER ZONING'S RECORDS WE DO NOT HAVE A UNITY OF TITLE ON FILE FOR LOTS 19, 20 AND 20-4, IN BLOCK 147, PLEASE VISIT OUR SITE TO PRINT A CURRENT APPLICATION.
