RESOLUTION NO. 2021-133

A RESOLUTION OF THE CITY COMMISSION ACCEPTING A RECOMMENDATION OF THE CITY MANAGER TO WAIVE THE COMPETITIVE PROCESS OF THE PROCUREMENT CODE FOR THE PURCHASE A TOTAL OF FOUR SANITARY SUBMERSIBLE PUMPS FOR SANITARY PUMP STATION PROSPECT AND SPARE USE FROM XYLEM WATER SOLUTIONS INC. AS A "SOLE SOURCE PROCUREMENT", PURSUANT TO SECTION 2-689 OF THE CITY'S PROCUREMENT CODE.

WHEREAS, the two (2) submersible pumps at City's Sanitary Sewer Prospect, located at 70 Prospect Drive, need replacement due to their expired useful life; and

WHEREAS, the City is required to maintain spare pumps and equipment in order to comply with the Pump Station Operation and Maintenance Program as per Miami-Dade Code Section 24-42.2(13); and

WHEREAS, these pumps are an essential component of City's Sanitary Distribution System that are specifically designed to operate within parameters which are unique to that station; and

WHEREAS, the pumps requiring replacement at Sanitary Pump Station Prospect are two (2) Flygt 3HP Model NP-3085.070 and the spare pumps are two (2) Flygt HP Model NP-3102.070; and

WHEREAS, all Flygt brand pumps must be replaced in-kind with the same brand; and

WHEREAS, the replacement cost for these pumps is \$31,422.90; and

WHEREAS, any other brand will result in additional cost for design and other changes to the pump station system; and

WHEREAS, Xylem Water Solutions Company USA, Inc.is the exclusive supplier of Flygt Products for the State of Florida; and

WHEREAS, Section 2-689 of the Procurement Code entitled "Sole Source Procurement" authorizes an award without competitive bids when the procurement division conducted a good faith review of available sources and concluded that there in only one source available to fulfill the needs of the City; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts a recommendation of the City Manager to waive the competitive process and authorizes the City Manager to purchase a total of four sanitary submersible pumps for Sanitary Pump Station Prospect and for spares use from Xylem Water Solutions Inc., as a "sole source procurement," pursuant to Section 2-689 of the City's Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
