As part of an ongoing effort to enhance the health, safety, and welfare of the citizens of Coral Gables, a recent inspection was made of the premises at **1109 ALMERIA AVE**, Coral Gables, FL.

At that time, a Code Enforcement Officer found the following violation(s) evident on the property:

Violation(s):

• City Code - Chapter 105, section 105-23, F.B.C. - section 105.4.1.1. If work has commenced and the permit is revoked, becomes null and void, or expires because of lack of progress or abandonment, a new permit covering the proposed construction shall be obtained before proceeding with the work.

Code Enforcement Officer Comments: Permit is expired - BL-17-05-1219 (Residential Addition)

The following steps should be taken to correct the violation:

Remedy: Must reactivate permit, final all inspections and final permit out.

The Code Enforcement Division will re-inspect the property on **6/16/2019** to determine if corrective measures have been completed. If corrective measures have not been completed by **6/16/2019**, a Notice of Violation will be issued.

If this notice pertains to failure to maintain a historic structure, please be advised that:

- You may be subject to substantial fines that may not be mitigated.
- You may also be required to repair or restore the historic structure.
- If the historic structure is allowed to deteriorate to the point where it must be demolished:
 - the City Code requires that you replace the structure with a similar historicallyappropriate structure; and
 - o the property will no longer qualify for an historic preservation tax exemption.
