The owner shall repair the Fire Department deficiencies as to the Fire Alarm, Fire Sprinklers and exit signs prior to the Fire Department deadline of 2/22/21. D. If any of the requirement are not completed within the deadlines, the owner shall pay a daily fine of \$ 250 for each day the violation continues.
