I would like to nominate Officer Robert Wentzell and PPO Oswaldo Cabello for their display of courage, professionalism, and excellence on June 29, 2021. On this date, they were confronted with a deadly threat, and were able to take the subject into custody with the least amount of force necessary to affect an arrest.

While eating lunch at 5885 Ponce De Leon, they noticed a drunken patron who was seated adjacent to them at a table outside in the patio area. Without warning or provocation, the Offender removed a firearm from his waistband and slammed it on the table. Officer Wentzell and PPO Cabello took swift action. Officer Wentzell stood up, drew his weapon, and walked toward the threat. Officer Cabello, who had his back turned, instinctively got up and went toward the threat as well. As Officer Wentzell retrieved the firearm, PPO Cabello attempted to physically restrain the Offender. As the Offender continued to resist, he was eventually tasered by Officer Wentzell.

These Officers combined efforts may have averted a tragedy for the Citizens of Coral Gables and for the Coral Gables Police department.

NARRATIVE

On June 29, 2021, CGPD Officer O. Cabello ID# 11574 and I were seated in front of the business located at 5885 Ponce De Leon Blvd (Downstairs). At approximately 0320 hours, Mr. Manning Coney (Offender) arrived at the above location via foot and made contact with Mr. Joshua Smiley (Witness). Mr. Coney asked Mr. Smiley if he was buying pizza, to which Mr. Smiley replied, "No, I'm buying a sub." Mr. Coney proceeded to sit at the table located west of Officer Cabello and myself away from Mr. Smiley. At approximately 0324 hours, Mr. Coney while still seated next to CGPD officers brandished a 9mm SCCY firearm in a careless and negligent manner, while placing it on top of the table pointed directly in the direction where we were seated. I immediately alerted Officer Cabello of the situation, I took possession of the firearm and Officer Cabello attempted to take Mr. Coney into custody. Mr. Coney attempted to flee; Officer Cabello grabbed Mr. Coney placing his left hand on his shoulder and right arm under his left arm to gain control and take him into custody. Mr. Coney continued to resist while on the ground attempting to get up and not listening to CGPD officer's verbal commands. At this point, I deployed my electronic control device (Taser) to gain control of the subject. The Taser probes struck Mr. Coney in his stomach and torso area. Mr. Coney continued to resist arrest and the Taser was cycled 3 times on Mr. Coney before he complied with our instructions and was taken into custody. While Mr. Coney was in custody he stated to CGPD officers "You're not the only one with power."

Coral Gables Fire Rescue 2 responded to the scene and treated Mr. Coney for his injuries (See run #21004185). Lt. Sampedro removed the Taser probes from Mr. Coney. Mr. Coney was treated on the scene and released into the custody of CGPD officers.

Mr. Coney does not possess a license to carry a firearm. The firearm had no round in the chamber and a black, magazine with a total of five 9mm Luger rounds was inserted in the firearm.

Mr. Coney was transported to CGPD prisoner processing. While in prisoner processing Mr. Coney vomited on himself and on the floor. Coral Gables Fire Rescue 4 Lt. Simovitch responded, treated and released Mr. Coney on scene (See run #21004186). IPS Cleaning responded to the holding cell and cleaned the area where Mr. Coney was sick.

Mr. Coney was transported to TGK via CGPD processing procedures.

Sgt. Daniels (A400) and Sgt. St. Amand (A200) were both present on the scene.

The Taser probes and spent cartridges were impounded into the CGPD Property Room. Digital Photos were taken of the scene and of Mr. Coney where the Taser probes penetrated his skin. Those photos were uploaded to the CGPD X-Drive UPD Digital Photos under this case number.

The firearm, magazine, and 9mm rounds were also impounded into the CGPD property room and sent to Miami-Dade PD for analysis.

I responded to CGPD and met with Ofc. Wentzell (7661) and Ofc. Cabello (11574). They had arrested the subject, Manning Dejuan Coney, after he brandished a firearm (9mm SCCY) and placed it on a table pointed in their direction. They informed me that they were at the "Downstairs" shop located at 5885 Ponce de Leon Blvd and were seated at a table in the front of the store when the incident took place.

I read the subject his rights and he agreed to speak to me without having a lawyer present. The subject signed a Miranda Rights form to this effect. The interview was digitally recorded, and his Miranda Rights were administered to him during the recording.

The subject told me that he had gone to the establishment to get something to eat. He told me that he had been drinking but that he had not taken any narcotics. The subject was emitting a strong odor resembling that of alcohol but was adamant that he had ingested only one beer. The subject stated that he lived at 5900 SW 67th St with his grandmother. The subject stated that he was employed at the "Yumbrella" restaurant located at 5701 Sunset Rd as a dishwasher.

I asked the subject where he had acquired the firearm and he told me that he had purchased it at a pawn shop in North Miami last year; he could not remember the name of the pawn shop. He also stated that he did not have a concealed weapons permit. The subject informed me that he had a juvenile past and was also arrested for drug possession and strong-arm robbery.

I asked him about his motivation for taking out his firearm and antagonizing the officers with it. He told me that he wanted to show them that, "...they were not the only ones with power." The subject stated that he understood why the officers had to arrest him and that they were "nice".

The subject was arrested by Ofc. Wentzell and Ofc. Cabello and transported to TGK via CGPD process.

This case will be closed and cleared by arrest.
