RESOLUTION NO. 2021-287

A RESOLUTION OF THE CITY COMMISSION APPROVING ARTISTS FOR PUBLIC ART PROPOSAL SUBMITTALS ASSOCIATED WITH THE NEW PUBLIC PARKING GARAGE 7, MINORCA GARAGE. (UNANIMOUSLY RECOMMENDED BY THE CULTURAL DEVELOPMENT BOARD APPROVAL/DENIAL VOTE: 5 TO 0).

WHEREAS, the new Coral Gables Public Parking Garage 7 meets the requirement of a municipal construction project governed by the Miami-Dade County Code of Ordinances; and

WHEREAS, the City of Coral Gables provides for the acquisition and maintenance of art in public places consistent with Section 2-11.15 of the Miami-Dade County Code of Ordinances entitled "Works of Art in Public Places; and

WHEREAS, the Cultural Development Board recommends items of artistic and cultural significance to the City Commission; and

WHEREAS, a Request for Qualification (RFQ) was announced inviting artists to submit qualification and interest in developing a public art design for the new Coral Gables Public Safety Building; and

WHEREAS, seventy-ninety applications were received in response to the RFQ; and

WHEREAS, the Arts Advisory Panel met and made a recommendation to the Cultural Development Board to invite four artists to submit design proposals for the new Coral Gables Public Parking Garage 7; and

WHEREAS, the Cultural Development Board met and recommends artists: Grimanesa Amoros, Brookhart Jonquil, Monika Bravo, and Ivan Toth Depena to submit public art design proposals for the new Coral Gables Public Parking Garage 7; and

WHEREAS, funds for the proposal process up to \$15,000 are proposed through use of the art acquisition fund;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES AS FOLLOWS:

SECTION 1. That the foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon the adoption hereof.

SECTION 2. The City Commission does hereby authorize artists Grimanesa Amoros, Brookhart Jonquil, Monika Bravo, and Ivan Toth Depena to submit public art design proposals for the new Coral Gables Public Parking Garage 7; allowing for \$15,000 from the Art Acquisition Fund to cover the proposal process.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
