2020 (sic) amended annual budget to recognize as revenue proceeds from the sale of the Doctors

Hospital -- the expected sale of Doctors Hospital and the Greco lot -- parking lots, the receipt of

the Agave Developer Fee, and Coral Gables Mobility Impact Fee; and to appropriate such funds

to put toward the Minorca Garage Construction Project, the Public Safety Building Construction

Project, the future purchase of land, and enhancement of parks; and providing an effective date.

Mayor Lago: Keith, good afternoon.

Vice Mayor Mena: I have the agenda item, but which attachment is it?

Finance Director Gomez: So, the Resolution 2020-199, it talks about how -- because I have it in

front of me. The 50 percent of it goes towards the new Public Safety Building, 25 percent towards

acquisition of parkland, and 25 percent towards parks improvements. That has to do with the

Doctors Hospital lot, which is the piece that Keith had mentioned earlier.

Assistant Finance Director Kleiman: Right.

Finance Director Gomez: So, that's a portion of it. There's other sections of this amendment, other

dollars. So, for instance, there's also the sale of the Greco Street lot, the anticipated sale of \$3.525

million. That's -- we're putting that towards appropriating that towards the Minorca garage. The

Agave developer fee, that's \$2.7 million. That's going towards the Public Safety Building. And

then some mobility impact fees that are going towards the Minorca garage as well, so we're

appropriating all four of those projects -- or all four of those dollars towards the individual projects

in the budget amendment to do them all.

Commissioner Fors: And I think -- just I guess to respond to the attorney who spoke earlier, I

think what that boils down to is that they are saying -- or the Agave group is saying they had an

expectation...

Finance Director Gomez: Right.

Commissioner Fors: Of receiving those funds for art and I appreciate that. At the same time, I

think, you know (INAUDIBLE), I think I reviewed the documents, and at the end of the day, the

City didn't contractually obligate itself to do -- there was specific language in there which may or

may not have stated preferences for using it for one thing or the other, but we deliberately left it

open to be able to make the call later on. What we're seeing here today is making the call to use it

for public safety instead of for art. As I always say, you know, I wish money grew on trees, then

we'd use it -- we'd have money for the public safety and for the art. Unfortunately, in this particular

case, with these distinct funds, we have to make a decision between one or the other. I understand

that they had some kind of expectation to use it on art. It's a tough decision for me to make, but at

the end of the day, I think if you poll our residents today, you'd find that the overwhelming number

would want us to use it on public safety under these specific circumstances. So, that's where I'm

at with that in terms of allocating it to public safety over art at this time.

Vice Mayor Mena: And what did the second amended development agreement say exactly?

City Attorney Ramos: It said -- it listed public safety or art, with a preference for art, but at the

Commission's discretion.

Commissioner Menendez: So, the key is the discretion part...

City Attorney Ramos: Correct.

Commissioner Menendez: Gives us the flexibility.

City Attorney Ramos: Correct.

Commissioner Menendez: I have just a question. And I too, you know, definitely public safety is

paramount to what we do as a government. Of the dollar amounts you -- in the resolution for the

different projects, is this the only one that we're coming to this decision now, or are a lot of these

also in the same situation, where we identified these dollars recently to move them over? I just

want to see, you know...

Finance Director Gomez: Sure. So, for all -- the four different -- they've all been discussed over

the past however long it's been discussed. And so, in terms of when we're doing the budget and

we have funding gaps and we have to figure out how are you going to fund the things that need to

be funded, we've identified the sale, for instance, of Doctors Hospital, the sale of the Greco lot.

You know, what are we going to use those monies for, the developer fee. And so, we've -- in a

sense, we've plugged those holes hoping that these monies could be used for those purposes. It's

been discussed at previous meetings, for instance, the one on Doctors Hospital where there was a

specific -- it said X percentage goes to public safety, and then 25 percent to parks. That was very

clearly laid out there. The Agave development agreement said public safety or art, you know,

preference of art, but at the end of the day, it was left open. The Greco property at all the boards,

it was discussed that that will go back into parking in some form or fashion, so the Minorca garage

had a hole. So, we said, okay, that's where it makes sense. The mobility fees, it's just -- it's \$50,000

of mobility fees that we feel that we can use it towards the Minorca garage as well, so it's not a

larger -- a very large amount, but it's mobility impact fees that have to be used for certain purposes,

so we used those -- we recommend use of those funds for the purposes that the need is there.

Vice Mayor Mena: So was the...

Finance Director Gomez: So...

Vice Mayor Mena: Sorry, was the...

Finance Director Gomez: No. no.

Vice Mayor Mena: When the development agreement was originally signed and then amended,

there was obviously some discussion at the time of the art preference for art or public safety, which

I understand.

Commissioner Anderson: Right.

Vice Mayor Mena: But was it -- when we say public safety, it's obviously a very broad umbrella,

right? And was it -- did it contemplate something specific or like additional public safety needed

as a result of new development, or was it just...

Finance Director Gomez: So, from our...

Vice Mayor Mena: Because it's basic...

Finance Director Gomez: Yeah.

Vice Mayor Mena: Because you're basically telling me, it's a reimbursement sort of.

Finance Director Gomez: It's money -- we were in the process of building the new Public Safety

Building, so we...

Vice Mayor Mena: Right.

Finance Director Gomez: Saw it as funding opportunities. Obviously, the Public Safety Building

went from X dollars to much more than what is originally intended, so we had to find funding

options. So, the 2.7 at least from Finance and Budget -- I know there was discussions with the

development agreement, whatever. We always anticipated that full \$2.7 million was going to

come to help fund the Public Safety Building. Then there were some discussions, a possibility of

part of it going to art and this and that. For us, it created a difficulty, right? We had to fund -- we

would have to then find the amount that theoretically would go to art would be about \$950,000.

We'd have to find that out of other funds to fill the Public Safety Building gap...

Mayor Lago: And I think you're for...

Finance Director Gomez: Of funding.

Mayor Lago: Madam Director, I think you're forgetting a very important point. And that is this -

- and I've been a proponent of the art, and I'm not going to compete -- like Commissioner Menendez

said -- whether it's going to be public safety or it's going to be art. Obviously, public safety is

paramount. There's no argument; there's no discussion. COVID came.

Finance Director Gomez: Right.

Commissioner Anderson: Right.

Mayor Lago: And we keep forgetting that, you know, we lost significant monies over the last two

years -- \$20 million over two years would you say was the final number?

Finance Director Gomez: Yep.

Mayor Lago: I just want to make sure. I don't know if it's 21 or 22. So, we're talking about a

significant amount of money that has resulted in all of us having to take a haircut on all fronts. So,

this is very tough for me in a sense because I see the commitment from the developer in regards to

world-class art, and they've made a significant commitment and they've delivered on that

commitment. Again, it's also a massive project in scale, and you know, we're at the crossroads

right now where a decision has to be made. And I think COVID has only exacerbated that decision,

and you know, and it's a tough decision to make, but at the end of the day, we've got to move

forward on this issue.

multiple arguments on why we should -- how we should skin the cat in regards to the sale, but

those discussions are done. We're moving forward, you know, and it's time to make a decision

here today.

Commissioner Menendez: And I agree with the Mayor. A decision will be made today. I'm

confident of that. My only thing as a Commissioner is I think maybe my colleagues would

appreciate if the City knows that it's leaning in one direction with the regards to future funds in a

situation like this where it can go one way or the other, it's probably -- you know, we would

appreciate -- at least I would appreciate to be given a heads up because this sort of came to me sort

of with short notice. I understand, so I know what -- how I have to, you know, vote, but sometimes

it helps us process it and maybe find other solutions, so that's my only comment. But again, my -

- you know, public safety first, but I'd like to maybe tweak that process in the future, so we have

more time to process it.

City Attorney Ramos: Vice Mayor.

Finance Director Gomez: And I think a lot of these discussions happened prior to your time on

the Commission because we had discussed the Doctors Hospital for the past I don't know how

long, the same with the Greco -- when the issue with the Greco lot came up, we did talk about

possibly using that.

Vice Mayor Mena: I -- yeah, no...

Vice Mayor Mena: Thrilled about because, you know, we did give an indication that there was a preference. And I get that we're in a contractually sound place where we feel like we're okay doing that. And yes, as a fiduciary of the City's finances, I get it where we are today. And so -- but I don't like kind of, you know, there was an expectation as partners with these people on this project. You know, and I just -- even though we have the right to do it, you know, I'm not thrilled about it to be honest with you. And my issue -- and I should have taken the time -- I didn't frankly -- to -- I would have -- I wish I had gone back to look at like the transcripts of when we discussed the development agreement and its amendments and sort of -- that's what I was asking earlier about when we said public safety or -- like what...

City Attorney Ramos: So, Vice Mayor, I can read you the language.

Vice Mayor Mena: Was there something particular contemplated for public safety, or was it always...?

City Attorney Ramos: It said all or part of the contribution may be used for public safety needs.

But above that, it says the allocation of the contribution is at the sole discretion of the City

Commission with the stated preference of the City Commission being that additional contribution

be utilized for public art improvements to the greatest extent possible.

Commissioner Anderson: I did view that particular meeting, and my impression was it was left to

the discretion, and there...

Vice Mayor Mena: Sure.

Commissioner Anderson: Always was -- and I remember the City Manager was discussing the

Public Safety Building in particular at that time. Things have changed since then. There were

additional costs. We've had COVID. I did bring this issue up when I had my mixed Zoom and

residents meeting here on Friday, and we do have -- I had not a single objection to this proposal

that we have here today. So, as far as community support, that's what I can tell you.

Vice Mayor Mena: Okay.

Commissioner Fors: And you know, I mean, I think at the end of the day, you have expectations,

but lawyers were involved. They're big girls and boys. Any lawyer will tell you when you're

reading that agreement that you are not -- you shouldn't have a real expectation. You can have a

well-founded hope that it will be used for art if that's what you want, but you know, I don't know

how much of a concrete expectation you can formulate based on that. I'm against adding warm

and fuzzy language in agreements like that period because then you run into these situations. And

as we all know that language about the Commission stated preference while still reserving

discretion is meaningless. Why even include it there? Because then folks, you know, do develop

potentially expectations. So, that's all I have to say on that.

the way, I don't want to scare anybody. The City is in impeccable financial shape.

Vice Mayor Mena: Yeah, yeah, of course.

Mayor Lago: But we're not going to overspend and put ourselves in a position in five years where

we're going to be a detriment to our future, so we're being very thoughtful and very methodical,

and as you can see, we're not -- we're spending this money in regards to public safety. My record

on the arts speaks for itself. I've presented resolutions. I've put it on the agenda. I have fought

for this item, and I think it's an important item. But at this point, we're moving forward. You

know, I understand my colleagues' position on this and the administration's position on this, and

there's nothing else that can be done. I -- you know, we've given the applicant -- not the applicant,

but the developer an opportunity to speak on this issue. We have negotiated this issue, as the City

Attorney will tell you, for years on this Commission floor. I've present -- I've been the one that's

presented the legislation and brought it up as topics of discussion. But we're at a crossroads. It's

time to make a decision.

Vice Mayor Mena: Yep.

Mayor Lago: We need to stop talking about this issue and memorialize it unless -- I mean, again,

I don't mean -- I don't want to stifle the conversation. I'm just saying it's time to make a decision.

Commissioner Fors: In conclusion, I think Commissioner Mena's -- and tell me if I'm right or

wrong -- that your concern is not necessarily about choosing public safety over art in these

circumstances, but it going to pay for the Public Safety Building? Or are you advocating for it

going to art?

Vice Mayor Mena: No, no, no. My concern was when the decision was made for it to say public

safety or art in the context of a development agreement that was being signed, I don't -- I just don't

recall what the discussion was, if there was something particular in mind, public safety-wise.

Because I don't think at the time we knew we were over budget. I don't recall the exact timing.

Finance Director Gomez: At the amendment time -- no, at the amendment time...

Vice Mayor Mena: Maybe at the amendment we were.

Finance Director Gomez: Yeah.

Vice Mayor Mena: Okay.

Finance Director Gomez: No, we needed the money towards the Public Safety Building at that

point.
