Mayor Lago: Which one?

City Attorney Ramos: We may want to leave that one for the end.

Vice Mayor Mena: Yeah, let's do this one first.

City Attorney Ramos: Okay, let's do H-7 first...

Vice Mayor Mena: Yeah, the other one is...

City Attorney Ramos: Or H-1.

Commissioner Menendez: H-1.

Arts and Culture Specialist Cathers: Good afternoon, Mayor, Vice Mayor, Commissioners.

Mayor Lago: Thank you for your patience.

Arts and Culture Specialist Cathers: Thank you.

(BREAK IN AUDIO)

Mayor Lago: Providing them with a fee for the conceptual drawing or concept?

Arts and Culture Specialist Cathers: Yes, so today, we're also asking for access to the Art Acquisition Fund for \$15,000 -- up to \$15,000, I should say, to cover those costs.

Mayor Lago: Okay, I don't have any issues moving forward. I had a nice meeting. We went over

all the details. But I just want to put certain things on the record, and I spoke to the Manager about

this. I would like to see in the near future, since we have certain projects that are significant, but

when you add up the numbers of the fees in regards to the art acquisition that if we potentially put

them all together in a bundle, we could significantly acquire a world-class piece of art versus doing

five smaller works that are going to require a lot more maintenance. And we could potentially

chase a work of art that could be -- again, it doesn't have to be huge, but it could carry a significant

weight in regards to international stature. You have certain projects like 427, you have Parking

Garage 7 that we just talked about, and you have the Fink Studio.

City Manager Iglesias: Fink Studio.

Mayor Lago: I think the Fink and 427 are smaller projects that you could bundle together and

potentially do something great with either a local artist or an international artist, using an outside

consultant that we have multiple that have helped out here in the City with different projects or,

you know, speak to the Arts Advisory Council. See if they can recommend anybody. But I've just

thought about maybe bundling some of these projects together. If Parking Garage 7 does not meet

what my expectations are in regards to the cost, I tell you now, I will vote no. I'm not going to

vote yes in favor of projects that in my opinion do a disservice to the art portfolio that we're

building here in the City. That does not -- that's not an indictment on the artist. I think all the

artists are great, but I want something exceptional. I want something that is beautiful and that is,

again, that is inviting to the community, that really sets a benchmark in regards to quality. So, I

just want to put that out there, and I spoke to the Manager about that, and maybe you can brief my

colleagues alone. It doesn't have to be now, and potentially see if we can run with that idea to

bundle some of these smaller projects together.

City Manager Iglesias: Mayor, you're thinking about bundling the parking garage, 427, and Fink

together, all three is possible?

Mayor Lago: Yep.

City Manager Iglesias: To look at that possibility. Let's look at that possibility. We will look at

that possibility and come back, depending on what we have in Parking Garage 7.

Mayor Lago: So, again, I just...

Commissioner Anderson: Alright.

Mayor Lago: That's just an idea that I had. And I also mentioned to -- and I'll put it on the record

here. In regards to the beautiful parking garage that we're having conceptual designs for on

Andalusia, I don't know -- I know my colleagues maybe have had potentially an opportunity to see

that garage. It is beautiful. Something that I had the pleasure of enjoying, and we have them here

in the City, and the Carlos Cruz Diaz crosswalks. If you look at Carlos Cruz Diaz works

internationally, we're talking about probably in 40 or 50 different cities all over the world, he has

vertical hanging sculptures that have been used in metal steel buildings, so they would fit perfectly

well with that proposed conceptual design for that parking garage. I've spoken to the estate, and a

lot of that -- he designed a lot of work before his passing, so maybe that could be something that

we consider that would fit in perfectly, you know, with the design of that building. But I asked

you to take a look at -- if you can, take a look at some of his work internationally in other public

buildings throughout the world, where you can see how maybe -- how there's a nexus between the

artist and the conceptual design of the building.

City Manager Iglesias: And we are looking at presenting to the Commissioner preliminary work

on the Mobility Hub in October.

Mayor Lago: Okay.

itself, for the artwork there, was at \$400,000. Are you proposing that we use that fund plus the

other buildings that you mentioned towards a project outside of that and not consider these artists,

or still consider these artists?

Mayor Lago: No, I would consider these artists, but I want to see what they have. But I'm putting

it on the record now...

Arts and Culture Specialist Cathers: Okay.

Mayor Lago: That if I'm not happy with what's proposed and it's not -- I'm not even looking for

good; I'm looking for exceptional.

Arts and Culture Specialist Cathers: Understood.

Mayor Lago: Okay.

Arts and Culture Specialist Cathers: So, we would move forward with that, with the proposal at

that fee, and then moving forward, the other buildings that you mentioned, and perhaps the fire

station...

Mayor Lago: Yes.

Arts and Culture Specialist Cathers: And bundle so that we can build up...

Mayor Lago: And I would like for you to have -- you know, for my colleagues to consider that.

We don't have to vote on that today, just to consider it. But it's a good opportunity to minimize

maintenance and it's an opportunity to really get a world-class piece of art instead of having three
