**The following steps should be taken to correct the violation:**

**Remedy: Must clean. Obtain approval and permit if necessary.**

The Code Enforcement Division will re-inspect the property on **12/5/2020** to determine if corrective measures have been completed. If corrective measures have not been completed by **12/5/2020**, a Notice of Violation will be issued.

The Division is available for consultation on this matter from 7:30 AM to 4:00 PM. Please do not hesitate to call the Code Enforcement Officer below for additional assistance.

**If this notice pertains to failure to maintain a historic structure, please be advised that:**

- **You may be subject to substantial fines that may not be mitigated.**
- **You may also be required to repair or restore the historic structure.**
- **If the historic structure is allowed to deteriorate to the point where it must be demolished:**
  - **the City Code requires that you replace the structure with a similar historically-appropriate structure; and**
  - **the property will no longer qualify for an historic preservation tax exemption.**



  - o **La propiedad ya no será elegible para una exención de impuestos por preservación histórica.**
