RESOLUTION NO. 2021-327

A RESOLUTION OF THE CITY COMMISSION AUTHORIZING THE DECLARATION OF SURPLUS AND SALE OF A CITY-OWNED SELF-LOADER TRUCK PURCHASED FOR THE SOLID WASTE DIVISION OF PUBLIC WORKS, PURSUANT TO SEC. 2-879 OF THE PROCUREMENT CODE ENTITLED "DISPOSAL OF SURPLUS".

WHEREAS, a Self-Loader truck (2021 International Chassis Model MV607) was purchased in December 2020 for the Solid Waste Division to assist with gaining efficiencies in the trash and garbage operations while replacing outdated equipment; and

WHEREAS, prior to the delivery of the equipment (July 2021), a transition in the operational environment of the Solid Waste division happened and it was determined that a different type of equipment would be better suited to meet the operational needs of the division; and

WHEREAS, after it was determined that the equipment would no longer meet the needs of the division, several options were considered for the best method to recoup the City's investment; and

WHEREAS, the City's Surplus Policy outlines that surplus property may be sold directly if a specific source has been identified and deemed in the City's best interest to pursue this route for disposal; and

WHEREAS, has been determined that the best option for the disposition of the equipment is to sell the equipment to EDJ Tree Service, LLC to allow the city to immediately recoup \$160,000 of its' original investment; and

WHEREAS, under Section 2-879 of the Procurement Code, entitled "Disposal of Surplus," the Chief Procurement Officer shall be responsible for the sale or disposition of surplus supplies by a method or methods deemed by the Chief Procurement Officer to be most advantageous and in the best interest of the city. The Chief Procurement Officer shall have the authority to sell or dispose of surplus items in any manner authorized by the appropriate Florida Statutes, including F.S. CH. 274, entitled "Tangible Personal Property Owned by Local Governments." All surplus items with an estimated fair market value of \$25,000.00 or more must be declared surplus by a Resolution of the city commission before the Chief Procurement Officer may dispose of said surplus supplies;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF CORAL GABLES:

SECTION 1. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.

SECTION 2. That the City Commission accepts the recommendation of the City Manager to declare the city-owned Self-Loader Truck as surplus and proceed with the direct sale of the truck to EDJ Tree Service, LLC for the purchase price of \$160,000 pursuant to Section 2-879 of the Procurement Code.

SECTION 3. That this Resolution shall become effective upon the date of its passage and adoption herein.
