[Note for the Record: Following the reading of the title to Agenda Item A-1, Mayor Cason asked that Kay Murff and Ana Louise Faulks, both members of the Landscape Advisory Board, Dana White of the Garden Club, and Brook Dannemiller of the Public Service Department, to join him at the dais. Commissioner Quesada stated that Coral Gables is a great community because of our trees and our parks, and the City Commission is thankful to both the Garden Club and Landscape Advisory Board for keeping that spirit going. Commissioner Quesada also pointed out that the Commission sets aside moneys for beautifying the community and it all comes back to trees.]

[Note for the Record: City Manager Swanson-Rivenbark announced that before continuing with the rest of the meeting, they would like to show a short video. Following the video presentation honoring Vice Mayor Kerdyk, Commissioner Lago stated he wanted to commend staff for doing an incredible job with the production of the video. Addressing members of the Kerdyk Family, Commissioner Lago said that what Vice Mayor Kerdyk has done is to be truly cherished and admired, adding that when he decided to run for office nearly four years ago, he knew who Bill, was but he was not aware of what Commissioner Kerdyk, Senior, had done, and, now, that he has had the pleasure of becoming more acquainted with the accomplishments of Commissioner Kerdyk, Senior. Commissioner Lago recognized Tracy Kerdyk for her hard work, explaining that they have worked on many projects together. Commissioner Lago also recognized Lindsay Kerdyk because, as Commissioner Lago's wife says, "the elected official is always recognized, but truly, the family behind that elected official deserves all the credit." Commissioner Lago thanked the Kerdyk Family for its commitment to the City and for allowing family members to serve the City for sixty years, because that is a big, big sacrifice. Commissioner Keon announced the City has a twenty-year pin for Vice Mayor Kerdyk, to recognize his twenty years of service to the City. Commissioner Quesada said that, as Commissioner Lago put it so eloquently, it is really the family behind the individual that allows the elected official to work late, miss family events and sacrifice family milestones to serve the City. Commissioner Quesada added that for all of the accomplishments of the Kerdyk Family - the idea for the City was George Merrick's, but it has really been the Kerdyk Family driving this train for the last seven decades. Commissioner Quesada said that many times, he and Vice Mayor Kerdyk did not agree on things, but he always respected his vote. One great point, referred Commissioner Quesada, is The Biltmore Hotel because for Coral Gables residents it is their country club, whether or not you are a member and had it not been for that difficult vote from Commissioner Kerdyk Senior, the City would not be what it is

Commissioner Quesada said that when Commissioner Kerdyk Senior was today. fighting for The Biltmore, it was not popular and it was very contentious; adding that Commissioner Kerdyk Senior had the vision of what was best for the City, and he was right. Commissioner Quesada ended his remarks by saying he would like to give Mrs. Kerdyk Senior the first-ever, sixty-year service pin for dealing with elected officials in Coral Gables - from her brother-in-law, to her husband and finally to her son. Mayor Cason stated he wanted to do two things: first, he wants to congratulate the Kerdyk Family and the second thing is he would like to turn over the gavel to Vice Mayor Kerdyk to be "Mayor for the Day" because he deserves that. Mayor Cason said that when he first came to Coral Gables five years ago from Paraguay and chose this City to live in, one of the first persons he met was Bill Kerdyk. They met in his office and spoke about the possibility of Mayor Cason running for elected office. Mayor Cason said Vice Mayor Kerdyk encouraged him, he ran for office, he won and it has been a tremendous pleasure seating on the dais next to Vice Mayor Kerdyk, adding there was no one else he would choose as Vice Mayor because there was a time when people rotated, but Vice Mayor Kerdyk was the person who had the experience and good judgment. Mayor Cason ended his comments by saying to Vice Mayor Kerdyk that he hopes he is only taking a rest for a few years because we need his wisdom and the stability he brings to our City because many of us are new and Vice Mayor Kerdyk is the person we can ask what happened here twenty years ago. Mayor Cason presented Vice Mayor Kerdyk with a floating Key to the City. Vice Mayor Kerdyk said that he wanted to say "thank you" to the general, police and fire employees, because they are the people that the residents reach out to - to the employee who picks up the recycling, to the police officer who keeps us safe, to the Fire Department, because in his twenty years he did not receive one complaint about how they handle events. Vice Mayor Kerdyk said he also wanted to thank the City Manager, the City Clerk and the City Attorney because they are the best and they work together and are really moving the City forward. Vice Mayor Kerdyk added that he also wanted to thank the people he has served with - Mayor Thomson, Mayor Valdes-Fauli, Commissioner Barker, Commissioner Withers, Commissioner Cabrera, Commissioner Anderson, and the individuals who serve with him here on the right now. Vice Mayor Kerdyk remarked that he was speaking with Mayor Thomson about the twenty years and it is crazy, his daughter was just born and the other daughter wasn't even born and time went by so fast, but if every day every Commissioner does a little to make the City better, every Commissioner can leave the City in a better place. Vice Mayor Kerdyk also thanked the residents for allowing him to serve for twenty years.

Mayor Thomson said she wanted to say something before leaving today and in witnessing this historical ceremony. Mayor Thomson stated that she served six years

that she learned a lot from Commissioner Kerdyk Senior when she first came in 1979, and Kerdyk Junior has done a wonderful job in carrying on the tradition of the Kerdyk Family. Mayor Thomson remarked that she knows, truly in her heart, that Commissioner Kerdyk Senior is very proud today of the things that his son, Commissioner Kerdyk Junior, has done. Commissioner Kerdyk thanked Mayor Thomson for everything she has done for the City.]
