#### **DISCUSSION ITEMS**

Discussion of Miami-Dade County's Inspection Interpretation by Peter J. Iglesias, P.E., Assistant City Manager/Building Official

Mr. Iglesias explained that Miami-Dade County's Board of Rules and Appeals September 2015's interpretation outlining the engineer's responsibilities in regards to the 40-year building recertification inspection was accurate and did not violate State Statutes. Engineers can make the determination on whether to inspect a percentage of a structure or request for all units to be inspected prior to approving the Recertification Report. It is the responsibility of the engineer to determine if the structure is functioning correctly as per the Code of the year it was built.

Mr. Iglesias asked the Members if they still wanted to send the proposed Resolution to the Commission for approval. The Members unanimously agreed to not pursue the Resolution requesting for Miami-Dade County to reconsider the interpretation.
