Twenty-five years of service is a milestone, and 25 years of service working for the City is also a milestone and today we celebrate one of our own, Major Cordell Atherley, who started as an officer and has worked in many facets of the Police Department, the Marine Patrol, Narcotics, and Training. Note for the Record: Following Mayor Valdes-Fauli’s reading of the title to Agenda Item 7 (i.e. Congratulations to Officer Justin Gonzalez, recipient of the City of Coral Gables “Officer of the Month Award,” for the month of December, 2018), Chief Hudak made the presentation.

Chief Hudak said that this award gets tougher and tougher for the Awards Selection Committee because they are doing such great work, not them, the officers; and that this is another example of when you hear the specifics of it, it is a combination of the officer’s initiative, and the technology that the City has invested in to apprehend individuals who prey on residents. Officer Eric Plescow, a Master Police Officer and nominator of the award, then gave a brief description on what occurred.

Officer Plescow stated that on December 19th, Officer Justin Gonzalez was working

a burglary task force when he responded to a call that they were all dispatched to at 1320 South Dixie Highway. While setting-up a perimeter around the building for a subject that had been breaking into businesses throughout the City, Officer Gonzalez saw a male individual matching that description running out of the building and observed that he had jumped over a wall, ran down South Dixie Highway and was running against traffic across the highway. Officer Gonzalez was able to apprehend the individual on the 1200 Block of South Dixie, and as a result CID was able to close 3 to 4 cases.

Chief Hudak said it was because of Officer Gonzalez' efforts and that of the rest of the members of the Uniform Patrol Division, and it was his honor to present Officer Gonzalez as the "Distinguished Officer of the Month" for December 2018.

Officer Gonzalez thanked Officer Plescow for the nomination, the Police Chief, the Major and all who had a part in him receiving the award. He said that day was just like no other; it was about being in the right place at the right time and letting his instincts go into play. He also acknowledged the officers who arrived on the scene, adding that it truly shows how quickly backup shows up, and additionally thanked the detectives who closed the cases to keep the defendant in jail; and that he was looking forward to the rest of his career.]

Vice Mayor Lago: I have one issue that I can bring up, if I may. I'd like to have, unless Commissioner Keon, ladies first, has something to say.

Commissioner Keon: Go ahead. I have a couple of things.

Vice Mayor Lago: Madam Dona Spain, could you please come up here? We have right now "X" amount of funds in regards to Art in Public Places for Miracle Mile and we also have "X" amount of funds that she's going to go over for the Police Station. I'm interested in potentially having a discussion with a well-renowned artist who's

going to be having a mid-career retrospective in a very prominent museum here in South Florida. This individual also happens to be from South Florida, and is currently living in New York and she's considered one of the most important artists in the world. I don't want to mention the name right now, because I haven't even reached out to her yet. What I'd like to see is if this Commission would give me the latitude to have a conversation with her about potentially becoming involved with Miracle Mile, as potentially including one sculpture. I'd like for Dona...

Mayor Valdes-Fauli: It has to come before us...

Vice Mayor Lago: Of course - of course. I just wanted to kind of have a little conversation and then have Dona take it from here.

Historic Preservation Officer Spain: So, what we would like is to have the City Commission take that money that was set aside for Miracle Mile, which I think is between \$500 and \$600,000 we have left, to use some of it for the Giralda sculptures and have us be allowed to put that back into the Art Acquisition Fund, so that it's available for an artist such as this artist that you are talking about.

Vice Mayor Lago: And, what is your opinion of this artist? I will share off-camera with my colleagues, if I can, if it's not a Sunshine issue, you never know. You've got to be careful now-a-days. What is your opinion in regards to this artist?

Historic Preservation Officer Spain: This artist is really a no-brainer as far as being world-class. It would be a real coo for the City to have a permanent installation of this artist. I would not like to have the artist only look at Miracle Mile. I would like to be able to have the artist look elsewhere in the City, but I really would like that money be freed up from Miracle Mile, because it's a chunk of change and then we can use it. I have to go through the process to get back here.

Vice Mayor Lago: Of course.

Historic Preservation Officer Spain: But, it's the only way that we can afford something of this caliber.

Vice Mayor Lago: And, I just want you to have the trust in me that I'm going to bring you something. She may say no, but I just want you to have the trust in my that I'm going to bring you something that's going to be extraordinary, and that I think it would

be up to the level of Coral Gables.

Historic Preservation Officer Spain: I'm not sure about the Public Safety Building money though.

Vice Mayor Lago: No. I just thought about if we were short, let's say, because I know that she has done major world-class commissions for New York and other major cities, not only domestically, but internationally; and I have always thought that if we are short on monies and we haven't made a decision yet on the Public Safety Building, maybe, we could use some of that money, because a decision hasn't been made yet. I just want to bring some...

Historic Preservation Officer Spain: The process is in the works. We do have set aside \$130,000 for this year's Art Basel, so we can certainly add that to that amount of money so that it gets out there. And the money that the Public Safety Building is going to generate in Art in Public Places is substantial to be put into the Art Acquisition Fund, so if we can narrow down what that is, that would be available also.

Vice Mayor Lago: So, what I would like to do is have a discussion with this artist. I'm going to potentially call her today, and then maybe I can bring it back to you or write a memo, and I'll share it with you her opinion of whether she is willing to become involved in the City.

Historic Preservation Officer Spain: We haven't discussed anything with the artist, so we didn't want to have it out in the public.
