Referred as 5301 Ponce de Leon Blvd, Coral Gables, FL; located at the northeast corner of Ponce de Leon Boulevard and Merrick Drive; generally described as a parcel of land laying in Tract 6, amended plat, portion of Main Campus University of Miami, according to the plat thereof recorded in Plat Book 46 at page 81, of the Public Records of Miami-Dade County, Florida (legal description on file). The application requests Preliminary Design review and approval for the construction of a new FPL substation on the Main Campus of the University of Miami.
