LOCAL HISTORIC DESIGNATION:

CASE FILE LHD 2019-001 AND COA (SP) 2019-002: Consideration of the local historic designation of the property at 1210 Sevilla Avenue, legally described as Lot 12, Block 8, Coral Gables Country Club Section Part One, according to the Plat thereof, as recorded in Plat Book 8, at Page 108 of the Public Records of Miami-Dade County, Florida. The applicant is also requesting the issuance of an Accelerated Special Certificate of Appropriateness and design approval for additions and alterations to the residence and detached auxiliary structure and sitework.
