A Resolution of the City Commission granting the authorization to waive the competitive process to purchase GovQA Solutions' OMS platform maintenance, support and service as a "Sole Source", pursuant to Section 2-689 of the City's Procurement Code.

**WHEREAS**, the Information Technology purchased the GovQA Platform in February 2014 to operate the City Of Coral Gables Public Record Requests and Service Request systems and;

**WHEREAS**, the GovQA system supports the electronic processes for Public Record Requests and Service requests and is used by the constituents, citizens and visitors.; and

**WHEREAS**, the IT Department has the need to renew the annual maintenance of the OMS Platform for a period of three (3) years at an approximately \$27,800 each year; and

WHEREAS, the City is seeking approval to purchase the on-going maintenance for the existing GovQA system that includes coverage for the domain subscription, cloud services, hosting fees and user tools; and

WHEREAS, Section 2-585 of the Procurement Code, entitled "Authority" authorizes the City Manager to delegate authority to the Procurement Officer to administer and make recommendations on contract awards;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CORAL GABLES:

**SECTION 1**. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution upon adoption hereof.
