A Resolution of the City Commission of the City of Coral Gables, Florida, relating to Security Services Assessments within the Hammock Oaks Harbor Security Guard Special Taxing District; estimating the cost of the security services to be assessed for the fiscal year commencing October 1, 2020; directing the City Manager to prepare an updated Security Services Assessment Roll; establishing a public hearing and directing the provision of notice in connection thereof; providing for severability; and providing an effective date.

In accordance with the Dade County Home Rule Charter and Chapter 18 of the Code of Metropolitan Dade County, in 1985 Dade County (the "County") enacted Ordinance No. 85-95 to create the Hammock Oaks Harbor Security Guard Special Taxing District to provide enhanced security services to properties within the District. Pursuant to Section 18-3.1 of the Code of Metropolitan Dade County, after approval by referendum and a joint resolution of the County and City of Coral Gables, governance and control of the District was transferred from the County to the City effective on October 1, 2018. Pursuant to the interlocal agreement between the County and the City outlining the transfer of governance, the City is responsible for establishing assessment rates and collecting assessments for the Special Taxing District. Pursuant to this agreement, the City adopted the Initial Assessment Resolution (Resolution Number 2018-197) on July 10, 2018, and the Final Assessment Resolution (Resolution Number 2018-248) was adopted on September 13, 2018.

Pursuant to the Master Assessment Ordinance (No. 2015-09), this resolution initiates the annual process for updating the Assessment Roll, sets the assessment rates for the fiscal year beginning October 1, 2020, calls for the public hearing on these rates, and directs the provision of notice.

There is no change in the proposed methodology. There is a proposed increase in this year's assessment to allow for new patrol services. The FY2021 assessment is \$2,698.80 per improved unit or \$1,349.40 for vacant

units without the new patrol services, and \$3,898.80 per improved unit or \$1,949.40 for vacant units if the new patrol services are adopted. Currently there is a petition process underway to determine if the new patrol services will be adopted. Therefore, the Preliminary Assessment will be set at the higher rate in order to allow for the additional services, however, should the petition fail, the lower rate will be set at the public hearing scheduled for September 10, 2020.
