Following the adoption of Ordinance No. 2017-30 enumerating the duties and powers of the Office of Mayor, this Ordinance serves the same purpose of enumerating the duties and powers of the Office of City Commissioner. The Ordinance includes each Commissioner having an office budget in an amount determined in the City budget. It also addresses who serves as Chair of the City Commission, in the Mayor's absence, how to call a special meeting and the permissibility of one-way communications by a Commissioner.
